ROAD TRAFFIC ACT 1961

ROAD TRAFFIC (MOTOR VEHICLES, REGISTRATION AND LICENSING) (AMENDMENT) RULES 2024

In exercise of the powers conferred by section 34 of the Road Traffic Act 1961, the Minister for Transport makes the following Rules:

Citation and commencement

1. These Rules are the Road Traffic (Motor Vehicles, Registration and Licensing) (Amendment) Rules 2024 and are deemed to have come into operation on 1 January 2024.

Amendment of rule 3

2. In the Road Traffic (Motor Vehicles, Registration and Licensing) Rules (R 5) (called in these Rules the principal Rules), in rule 3(2)(b)(ii), replace “\$27.82” with “\$28.34”.

Amendment of rule 3D

3. In the principal Rules, in rule 3D —

(a) in paragraph (5)(ii), replace “\$423.72” with “\$431.64”;
and

(b) in paragraph (7), replace “\$21.40” with “\$21.80”.

Amendment of rule 3E

4. In the principal Rules, in rule 3E(4), replace “\$32.10” with “\$32.70”.

Amendment of rule 3F

5. In the principal Rules, in rule 3F(1), replace “\$41.73” with “\$42.51”.

Amendment of rule 8

6. In the principal Rules, in rule 8(14), replace “\$21.40” with “\$21.80”.

Amendment of rule 9B

7. In the principal Rules, in rule 9B(9)(c), replace “\$41.73” with “\$42.51”.
