CONSTITUTION OF THE REPUBLIC OF SINGAPORE

CONSTITUTION OF THE REPUBLIC OF SINGAPORE (MINISTERIAL RESPONSIBILITY) (AMENDMENT NO. 4) NOTIFICATION 2024

In exercise of the powers conferred by Article 30 of the Constitution of the Republic of Singapore, the Prime Minister makes the following Notification:

Citation and commencement

1.—(1) This Notification is the Constitution of the Republic of Singapore (Ministerial Responsibility) (Amendment No. 4) Notification 2024.

(2) Paragraph 4(a) and (d) is deemed to have come into operation on 3 August 2021.

(3) Paragraphs 5 and 6(a) are deemed to have come into operation on 21 November 2021.

(4) Paragraph 4(b) and (c) is deemed to have come into operation on 31 January 2022.

(5) Paragraph 4(e) is deemed to have come into operation on 29 July 2022.

(6) Paragraph 4(f) is deemed to have come into operation on 1 August 2022.

(7) Paragraph 6(b) comes into operation on 28 March 2024.

(8) Paragraphs 2 and 3 come into operation on 1 April 2024.

Amendment of First Schedule

2. In the Constitution of the Republic of Singapore (Ministerial Responsibility) Notification 2020 (G.N. No. S 723/2020) (called in this Notification the principal Notification), in the First Schedule —

- (a) in item 2, in the second column, in paragraph 2(d), replace “Smart Nation and Digital Government Office” with “Smart Nation Group”; and
- (b) in item 15, in the second column, in paragraph 3, replace ““Smart Nation” Blueprint” with “Smart Nation Strategy”.

Amendment of Second Schedule

3. In the principal Notification, in the Second Schedule —

- (a) under the heading “**Departments**”, replace item 16 with —
“16. Smart Nation Group”; and
- (b) under the heading “**Subjects**”, replace item 17 with —
“17. Smart Nation Strategy”.

Amendment of Seventh Schedule

4. In the principal Notification, in the Seventh Schedule, under the heading “**Subjects**” —

- (a) in item 2(6), delete sub-paragraphs (b) and (c);
- (b) in item 2(6), delete sub-paragraphs (d), (g) and (i);
- (c) in item 2(6), replace sub-paragraph (e) with —
“(e) Government Securities (Debt Market and Investment) Act 1992”;
- (d) in item 2(6), after sub-paragraph (i), insert —
“(j) Significant Infrastructure Government Loan Act 2021”;
- (e) in item 10, delete paragraph (1); and
- (f) in item 10, delete paragraph (3).

Amendment of Eleventh Schedule

5. In the principal Notification, in the Eleventh Schedule, under the heading “**Subjects**”, in item 7(2), replace sub-paragraph (a) with —

- “(a) Copyright Act 2021”.

Amendment of Sixteenth Schedule

6. In the principal Notification, in the Sixteenth Schedule, under the heading “**Subjects**” —

- (a) in item 12, delete paragraph (2); and
- (b) after item 14, insert —

“14A. Significant Investments Review Act 2024”.
