CONSTITUTION OF THE REPUBLIC OF SINGAPORE

PUBLIC SERVICE (SPECIAL AND SENIOR PERSONNEL BOARDS) (AMENDMENT NO. 3) ORDER 2022

In exercise of the powers conferred by Article 110D(1) and (2) of the Constitution of the Republic of Singapore, the President, on the advice of Mr Chan Chun Sing, who is charged with the responsibility for public sector personnel and personnel-development policies, makes the following Order:

Citation and commencement

1.—(1) This Order is the Public Service (Special and Senior Personnel Boards) (Amendment No. 3) Order 2022 and, except for paragraph 2(2), comes into operation on 1 April 2022.

(2) Paragraph 2(2) comes into operation on 15 April 2022.

Amendment of Schedule
