Regulation

In exercise of the powers conferred by section 67(1) of the Active Mobility Act 2017, the Land Transport Authority of Singapore, with the approval of the Minister for Transport, makes the following Regulations:

**Citation and commencement**

1. These Regulations are the Active Mobility (Fees) Regulations 2018 and come into operation on 1 May 2018.

**Fees for moving vehicles, articles or things**

2.—(1) Where a vehicle is moved, or caused to be moved, to a holding yard or to another place under section 45 of the Act, the owner of the vehicle must pay to the Authority a fee for that moving specified in the First Schedule.

(2) Where a vehicle is seized and moved to a holding yard under section 50(1)(a) of the Act, the owner of the vehicle at the time of moving must pay to the Authority a fee for that moving specified in the First Schedule.

(3) Where an article or thing (other than a vehicle) is moved, or caused to be removed, under section 46 of the Act, the owner of the article or thing must pay to the Authority a fee for that moving specified in the First Schedule.

### **Fees for storing vehicles, articles or things**

3.—(1) Where a vehicle is stored in a holding yard or any other place for the purposes of section 45, 50 or 51 of the Act, the owner of the vehicle must pay to the Authority a fee for that storing at the applicable rate specified in the Second Schedule.

(2) Where an article or thing (other than a vehicle) is stored in a holding yard for the purposes of section 46 of the Act, the owner of the article or thing must pay to the Authority a fee for that storing at the applicable rate specified in the Second Schedule.

### **Waiver of fees**

4. The Authority may waive the payment (in whole or part) of any fee payable under these Regulations.

## **FIRST SCHEDULE**

Regulation 2

### **FEEES FOR MOVING VEHICLES, ARTICLES OR THINGS**

<i>First column</i>	<i>Second column</i>
1. Bicycle, power-assisted bicycle or personal mobility device	\$150
2. Any other vehicle	\$500
3. Any article or thing which is not a vehicle, weighing —	
(a) less than 20 kg	\$150
(b) 20 kg or heavier but less than 200 kg	\$360
(c) 200 kg or heavier	\$500

**SECOND SCHEDULE**

Regulation 3

**FEES FOR STORING VEHICLES, ARTICLES OR THINGS**

<i>First column</i>	<i>Second column</i>
1. Bicycle, power-assisted bicycle or personal mobility device	\$21.40 for each day or part of a day during which the vehicle is stored
2. Any other vehicle	\$171.20 for each day or part of a day during which the vehicle is stored
3. Any article or thing which is not a vehicle, weighing —	
(a) less than 20 kg	\$21.40 for each day or part of a day during which the article or thing is stored
(b) 20 kg or heavier but less than 200 kg	\$42.80 for each day or part of a day during which the article or thing is stored
(c) 200 kg or heavier	\$85.60 for each day or part of a day during which the article or thing is stored
