# CENTRAL PROVIDENT FUND (APPROVED MIDDLE-INCOME HOUSING SCHEME) (AMENDMENT) REGULATIONS 2024

In exercise of the powers conferred by section 77(1) of the Central Provident Fund Act 1953, the Minister for Manpower, after consulting with the Central Provident Fund Board, makes the following Regulations:

#### Citation and commencement

- 1.—(1) These Regulations are the Central Provident Fund (Approved Middle-Income Housing Scheme) (Amendment) Regulations 2024 and, except for regulation 4, come into operation on 1 April 2024.
- (2) Regulation 4 is deemed to have come into operation on 31 December 2021.

# Amendment of regulation 9
