### CONSTITUTION OF THE REPUBLIC OF SINGAPORE

#### PUBLIC SERVICE (SPECIAL AND SENIOR PERSONNEL BOARDS) (AMENDMENT) ORDER 2019

In exercise of the powers conferred by Article 110D(1) and (2) of the Constitution of the Republic of Singapore, the President, on the advice of Mr Chan Chun Sing, who is charged with the responsibility for the portfolio of the Prime Minister as regards public sector personnel and personnel-development policies, makes the following Order:

#### **Citation and commencement**

1. This Order is the Public Service (Special and Senior Personnel Boards) (Amendment) Order 2019 and comes into operation on 20 May 2019.

#### **Amendment of Schedule**

2. The Schedule to the Public Service (Special and Senior Personnel Boards) Order 2010 (G.N. No. S 824/2010) is amended —

- (a) by inserting, immediately after the name “Mrs Tan Ching Yee” in the third column of item 1, the name “Mr Loh Khum Yean”;
- (b) by deleting the name “Ms Yong Ying-I” in the third column of item 2 and substituting the name “Ms Chan Lai Fung”;
- (c) by inserting, immediately after the name “Mr Lee Chuan Teck” in the third column of item 2, the name “Mr Gabriel Lim”;
- (d) by deleting the name “Mr Gabriel Lim” in the third column of item 4 and substituting the name “Ms Yong Ying-I”;

- (e) by inserting, immediately after the name “Mr Ng How Yue” in the third column of item 4, the name “Mr Joseph Leong Weng Keong”;
- (f) by deleting the name “Mr Lai Chung Han” in the third column of item 5 and substituting the following names:
- “Mr Chew Hock Yong  
Mr Joseph Leong Weng Keong”;
- (g) by deleting the name “Ms Yong Ying-I” in the third column of item 6 and substituting the name “Mr Loh Khum Yean”;  
and
- (h) by deleting the name “Ms Chan Lai Fung” in the third column of item 6 and substituting the name “Ms Lai Wei Lin”.
