#### Citation and commencement

**1.** This Notification is the Intoxicating Substances (Approved Centres) Notification 2018 and comes into operation on 1 July 2018.

**2.** The Minister declares the places set out in the Schedule to be approved centres for the purpose of the treatment and rehabilitation of persons who use or inhale intoxicating substances for the purpose of inducing or causing a state of intoxication.
