# BUILDING CONTROL (COMPOSITION OF OFFENCES) REGULATIONS 2012

#### ARRANGEMENT OF REGULATIONS

#### Regulation

- 1. Citation and commencement
- 2. Compoundable offences
- 3. Revocation

In exercise of the powers conferred by section 48(3) of the Building Control Act, the Minister for National Development hereby makes the following Regulations:

# Citation and commencement

**1.** These Regulations may be cited as the Building Control (Composition of Offences) Regulations 2012 and shall come into operation on 3rd September 2012.

# Compoundable offences

- **2.** The following offences may be compounded by the Commissioner of Building Control in accordance with section 48 of the Act:
  - (a) an offence under section 7A(6), 8(4), 9(11), 10(9), 12(6), 13(2) or (3), 17(9), 22B(2), 22E(5), 33(4A) or 43(2) of the Act, other than a continuing offence under section 7A(6), 12(6), 22B(2) or 22E(5);

- (b) an offence under section 9(10)(b) of the Act in relation to the contravention of section 9(4)(d) or (e) of the Act, other than a continuing offence;
- (c) an offence under section 11(7)(a) of the Act in relation to the contravention of section 11(1)(c) of the Act, other than a continuing offence;
- (d) an offence under section 11(9)(a) of the Act in relation to the contravention of section 11(1)(e), (f), (g) or (h) or (4) of the Act;
- (e) an offence under section 11(9)(b) of the Act in relation to the contravention of section 11(2)(c) or (4) of the Act;
- (f) an offence under regulation 3(3), 6(3) (in relation to the contravention of regulation 6(1)), 7(6), 8(3) or 12(2) of the Building Control (Temporary Buildings) Regulations (Rg 5);
- (g) an offence under regulation 12 of the Building Control (Outdoor Advertising) Regulations (Rg 6);
- (h) an offence under regulation 41B(3), 41C(4), 41D(3) or 41E(2) of the Building Control Regulations 2003 (G.N. No. S 666/2003);
- (i) an offence under regulation 50 of the Building Control Regulations 2003 in relation to the contravention of regulation 25, 29(1) or (2), 30(1), (2), (3), (4), (5), or (6), 31(1), (2) or (3), 32, 33, 34, 34A, 35(1) or (2), 36(1) or (2), 37, 38(1) or (3), 40(1) or (2), 44, 45(1) or 46 of those Regulations;
- (*j*) an offence under paragraph 6(2) or 7(2) of the Building Control (Retrofitting of Casement Windows) Order 2004 (G.N. No. S 599/2004);
- (*k*) an offence under regulation 2(2) of the Building Control (Use of Buildings Under Construction as Workers' Quarters) Regulations 2008 (G.N. No. S 636/2008);
- (*l*) an offence under regulation 16(2) or 20E(3) of the Building Control (Licensing of Builders) Regulations 2008 (G.N. No. S 641/2008); and

(*m*) an offence under regulation 15 of the Building Control (Buildability) Regulations 2011 (G.N. No. S 199/2011) in relation to the contravention of regulation 8(1), 9(1) or (2), 10, 12(*a*), 13(1) or 14(1) of those Regulations.

# Revocation

**3.** The Building Control (Composition of Offences) Regulations (Rg 3) are revoked.
