### CONSTITUTION OF THE REPUBLIC OF SINGAPORE

#### PUBLIC SERVICE (SPECIAL AND SENIOR PERSONNEL BOARDS) (AMENDMENT NO. 5) ORDER 2017

In exercise of the powers conferred by Article 110D(1) and (2) of the Constitution of the Republic of Singapore, the President, on the advice of the Deputy Prime Minister and Coordinating Minister for National Security, Prime Minister's Office, Mr Teo Chee Hean, who is charged with the responsibility for the portfolio of the Prime Minister as regards human resource management in the Civil Service, makes the following Order:

#### **Citation and commencement**

1.—(1) This Order is the Public Service (Special and Senior Personnel Boards) (Amendment No. 5) Order 2017 and, except for paragraph 2(*f*) and (*k*), comes into operation on 1 September 2017.

(2) Paragraph 2(*f*) and (*k*) comes into operation on 1 October 2017.

#### **Amendment of Schedule**

2. The Schedule to the Public Service (Special and Senior Personnel Boards) Order 2010 (G.N. No. S 824/2010) is amended —

- (a) by deleting the name “Mr Peter Ong Boon Kwee” against the title of “Chairman” in the third column of item 1 and substituting the name “Mr Leo Yip”;
- (b) by deleting the name “Mr Leo Yip” against the title of “Members” in the third column of item 1;
- (c) by inserting, immediately after the words “the Strategy Group” in item 2(*a*), the words “, the Communications Group”;

- (d) by deleting the name “Mr Peter Ong Boon Kwee” in the third column of item 2 and substituting the name “Mr Leo Yip”;
- (e) by deleting the name “Mr Pang Kin Keong” in the third column of item 2 and substituting the name “Mr Loh Ngai Seng”;
- (f) by deleting the name “Mr Albert Chua” in the third column of item 2;
- (g) by deleting the name “Mr Peter Ong Boon Kwee” in the third column of item 3 and substituting the name “Ms Chan Lai Fung”;
- (h) by inserting, immediately after the name “Mr Leo Yip” in the third column of item 3, the name “Mr Pang Kin Keong”;
- (i) by deleting the words “, the Ministry of Social and Family Development or the Communications Group of the Prime Minister’s Office” in item 4(a) and substituting the words “or the Ministry of Social and Family Development”;
- (j) by deleting the name “Mr Leo Yip” in the third column of item 4;
- (k) by deleting the name “Mr Choi Shing Kwok” in the third column of item 4 and substituting the name “Mr Albert Chua”;
- (l) by deleting the name “Mr Leo Yip” in the third column of item 5 and substituting the name “Mr Pang Kin Keong”; and
- (m) by deleting the name “Mr Loh Ngai Seng” in the third column of item 5 and substituting the name “Mr Lai Chung Han”.
