In exercise of the powers conferred by section 65B(1) of the Housing and Development Act, the Minister for National Development, after consulting the Housing and Development Board, makes the following Order:

**Citation and commencement**

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 10) Order 2016 and comes into operation on 16 November 2016.

**Declaration of precincts for Home Improvement Programme**


2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

## THE SCHEDULE

1. All that part of the housing estate of the Board bounded by Jurong East Street 24, Jurong East Avenue 1 and Jurong East Central, comprised in Lot numbers 04969L, 04968X, 04967N, 04965A, 04966K, 03971C, 03970L, 03969M, 03968C, 04549N and 04973C in Mukim 05 and on which Apartment Blocks 241, 242, 243, 244, 245, 246, 247, 248, 249, 250 and 251 are erected, and which is more particularly shaded in Plan 1.

#### JURONG EAST STREET 24



All that part of the housing estate of the Board bounded by Jurong East Street 32, Jurong East Avenue 1, Jurong Town Hall Road and Pan Island Expressway, comprised in Lot numbers 03831N, 03823V, 03830K, 03822W, 04002L, 04001X, 04187W, 04186M, 04185C and 04184L in Mukim 05 and on which Apartment Blocks 301, 302, 303, 304, 305, 306, 307, 308, 309 and 310 are erected, and which is more particularly shaded in Plan 2.

JURONG EAST STREET 32



All that part of the housing estate of the Board bounded by Yishun Ring Road and Yishun Street 11, comprised in Lot numbers 00996L, 01013X, 00997C, 00998M, 00999W, 01002M, 01003W and 01004V in Mukim 19 and on which Apartment Blocks 121, 124, 125, 126, 127, 128, 130 and 131 are erected, and in Lot number 01012N in Mukim 19 and on which Apartment Blocks 122, 123 and 129 are erected, and which is more particularly shaded in Plan 3.

YISHUN STREET 11


