Citation and commencement

1. This Order is the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 8) Order 2019 and comes into operation on 12 September 2019.

Declaration of precincts for Home Improvement Programme


2. The parts of the housing estates of the Board described in the Schedule are declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

THE SCHEDULE

1. All that part of the housing estate of the Board bounded by Bukit Batok West Avenue 6 and Bukit Batok Central, comprised in Lot numbers 02059L, 02058X, 02056K, 02057N, 02074N, 02073K, 02072A and 02071T in Mukim 10 and on which Apartment Blocks 111, 112, 113, 114, 115, 116, 117 and 118 are erected, and which is more particularly shaded in Plan 1.

BUKIT BATOK WEST AVENUE 6



Plan 2



HOUGANG AVENUE 6




PLAN 4
