1. These Regulations may be cited as the Environmental Protection and Management (Composition of Offences) Regulations.

Composition of offences

2. Each of the following offences is prescribed as a compoundable offence that may be compounded in accordance with section 72 of the Act:

- (a) any offence under section 7(3), 8(3), 9(2), 11(1), 12(1), 14(2), 15(1), 16(3), 22(3), 23(3), 33(2), 35(6), 40C(2), 40D(3), 40G(6), 40I(3), 40J(9) (other than a continuing offence), 40L(4), 40N(5), 40O(3), 40P(2) (other than a continuing offence), 40Q(2) (other than a continuing offence), 40R(9), 40S(3), 40U(5) (other than a continuing offence), 40V(4), 40W(2), 40X, 44A(3) or 50A(2) of the Act;
