ARRANGEMENT OF REGULATIONS

Regulation

- 1. Citation and commencement
- 2. Compoundable offences

In exercise of the powers conferred by section 73 of the Infectious Diseases Act, the Minister for Health makes the following Regulations:

Citation and commencement

1. These Regulations are the Infectious Diseases (Composition of Offences) Regulations 2020 and come into operation on 12 February 2020.

Compoundable offences

- 2. The following offences (other than a continuing offence) may be compounded by the Director in accordance with section 68(1) of the Act:
