In exercise of the powers conferred by section 37 of the Weights and Measures Act, the Minister for Trade and Industry hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Weights and Measures (Fees) Regulations 2005 and shall come into operation on 1st January 2006.

Fees payable to Board

2. The fees specified in the second column of the Schedule shall be payable to the Board in respect of the matters specified in the first column thereof.

Revocation

3. The Weights and Measures (Fees) Regulations (Rg 2) are revoked.
