An Act to make supplementary provision to meet additional expenditure for the financial year 1 April 2015 to 31 March 2016.

Be it enacted by the President with the advice and consent of the Parliament of Singapore, as follows:

Short title

1. This Act is the Final Supply (FY 2015) Act 2016.

Supplementary supply from Consolidated Fund

- 2.—(1) A further sum of \$328,174,200, not otherwise provided for by the Supply Act 2015 (Act 8 of 2015), is authorised to be issued from the Consolidated Fund for the period from 1 April 2015 to 31 March 2016.
- (2) The sum in subsection (1) is appropriated for the Heads of Expenditure for the public service specified in the Schedule.

Supplementary supply from Development Fund

- **3.**—(1) A further sum of \$213,021,800, not otherwise provided for by the Supply Act 2015, is authorised to be issued from the Development Fund for the period from 1 April 2015 to 31 March 2016.
- (2) The sum in subsection (1) is appropriated for development purposes under the Heads of Expenditure specified in the Schedule.
