An Act to make supplementary provision to meet additional expenditure for the financial year 1 April 2018 to 31 March 2019.

Be it enacted by the President with the advice and consent of the Parliament of Singapore, as follows:

#### Short title

1. This Act is the Supplementary Supply (FY 2018) Act 2019.

## Supplementary supply from Consolidated Fund

- 2.—(1) A further sum of \$1,332,085,100, not otherwise provided for by the Supply Act 2018 (Act 13 of 2018), is authorised to be issued from the Consolidated Fund for the period starting 1 April 2018 and ending 31 March 2019.
- (2) The sum in subsection (1) is appropriated for the Heads of Expenditure for the public service specified in the Schedule.

## Supplementary supply from Development Fund

- 3.—(1) A further sum of \$294,912,500, not otherwise provided for by the Supply Act 2018, is authorised to be issued from the Development Fund for the period starting 1 April 2018 and ending 31 March 2019.
- (2) The sum in subsection (1) is appropriated for development purposes under the Heads of Expenditure specified in the Schedule.
