An Act to provide for the issue from the Consolidated Fund of the sums necessary to meet the estimated expenditure for the public services of Singapore for the year 1968.

Be it enacted by the President with the advice and consent of the Parliament of Singapore, as follows: —

Short title and commencement

1. This Act may be cited as the Supply Act, 1967, and shall come into operation on the 1st day of January 1968.

Supply \$555,810,150

2. A sum not exceeding five hundred and fifty-five million, eight hundred and ten thousand, one hundred and fifty dollars is hereby authorised to be issued from the Consolidated Fund for the period from the 1st day of January 1968, to the 31st day of December 1968, and the said sum may be expended as specified in the Schedule to this Act.
