A BILL

*intituled*

An Act to provide for the issue from the Consolidated Fund and the Development Fund of the sums necessary to meet the estimated expenditure for the financial year 1 April 2015 to 31 March 2016.

Be it enacted by the President with the advice and consent of the Parliament of Singapore, as follows:

## Short title and commencement

1. This Act may be cited as the Supply Act 2015 and comes into operation on 1 April 2015.

## Supply from Consolidated Fund

5 2.—(1) A sum not more than \$76,912,394,500 is authorised to be issued from the Consolidated Fund for the period from 1 April 2015 to 31 March 2016.

(2) The sum in subsection (1) is appropriated for the Heads of Expenditure for the public service specified in the Schedule.

## 10 Supply from Development Fund

3.—(1) A sum not more than \$30,788,559,800 is authorised to be issued from the Development Fund for the period from 1 April 2015 to 31 March 2016.

15 (2) The sum in subsection (1) is appropriated for development purposes under the Heads of Expenditure specified in the Schedule.
