GOVERNMENT CONTRACTS ACT 1966

GOVERNMENT CONTRACTS (AUTHORISATION) (AMENDMENT) NOTIFICATION 2023

In exercise of the powers conferred by section 2 of the Government Contracts Act 1966, the Minister for Finance makes the following Notification:

Citation and commencement

1. This Notification is the Government Contracts (Authorisation) (Amendment) Notification 2023 and comes into operation on 6 January 2023.

Amendment of First Schedule

2. In the First Schedule to the Government Contracts (Authorisation) Notification 2022 (G.N. No. S 318/2022) —

- (a) in Part 8, in item 23, in the second column, in paragraph (b), after “Period Contracts”, insert “or Framework Agreements”;
- (b) in Part 8, in item 34, in the second column, delete paragraphs (c) and (d);
- (c) replace Part 13 with —
