Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 3) Order 2012 and shall come into operation on 23rd March 2012.

Declaration of precincts for Home Improvement Programme

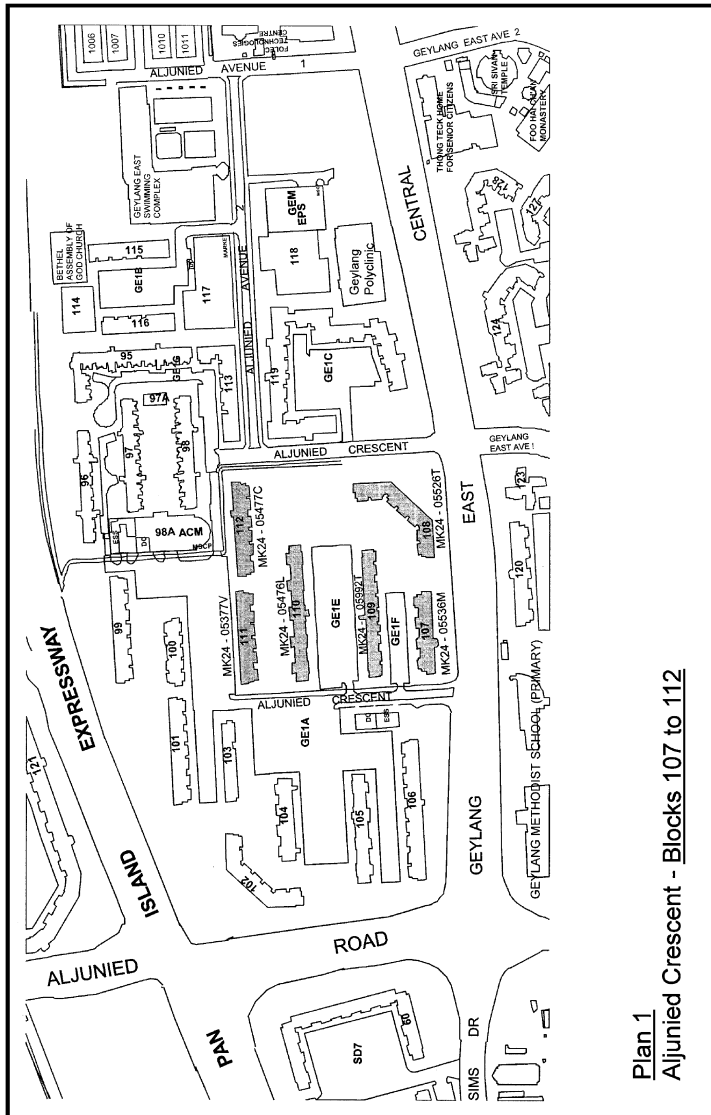
2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

1. All that part of the housing estate of the Board at Aljunied Crescent comprised in Lot numbers 05536M, 05526T, 05992T, 05476L, 05377V and 05477C in Mukim 24 and on which Apartment Blocks 107, 108, 109, 110, 111 and 112 are erected, and which is more particularly shaded in Plan 1.

ALJUNIED CRESCENT



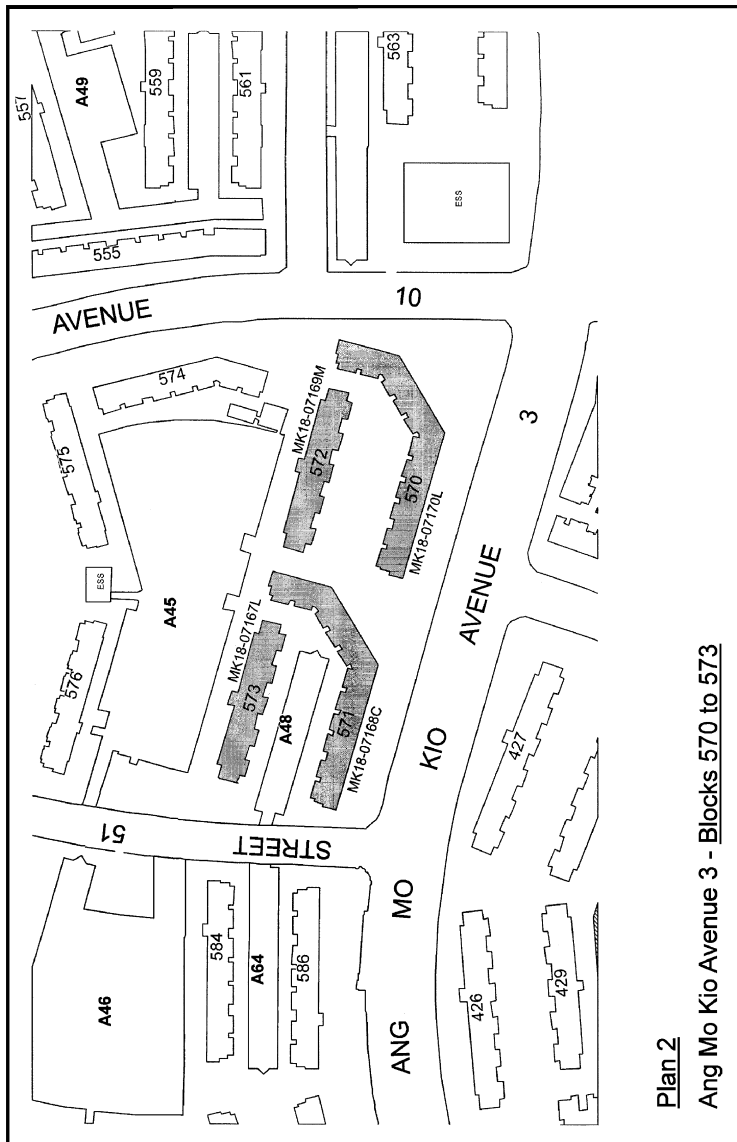
Plan 1

ANG MO KIO AVENUE 3



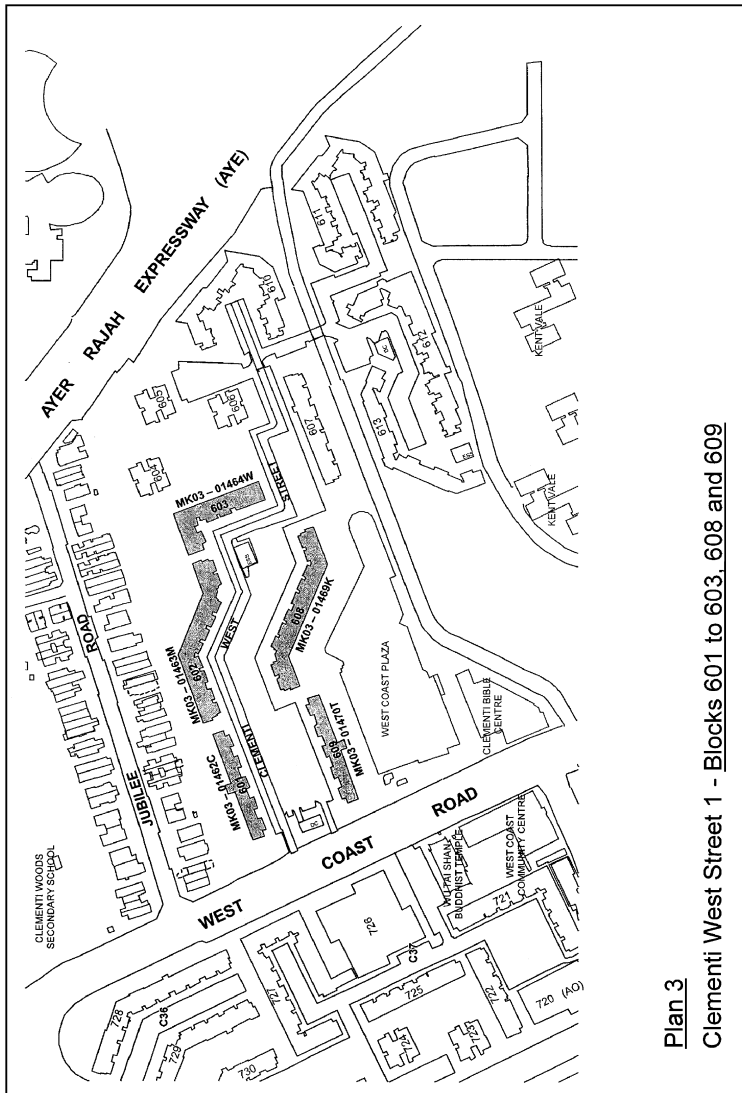
Plan 2

CLEMENTI WEST STREET 1



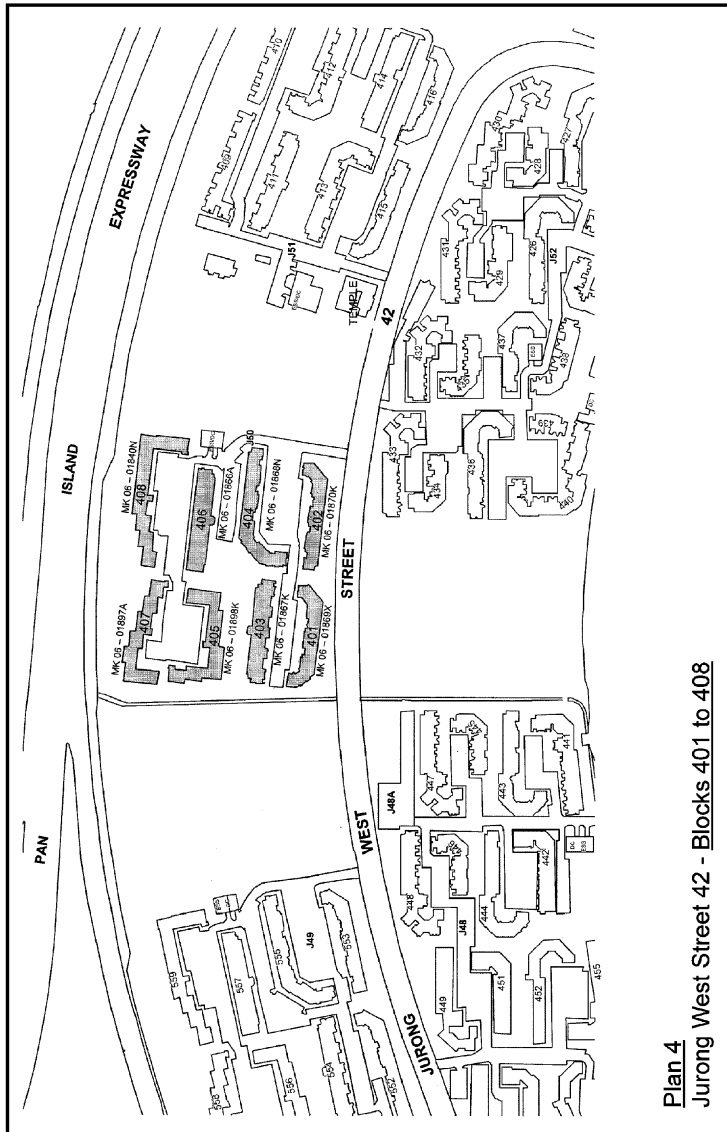
Plan 3

JURONG WEST STREET 42



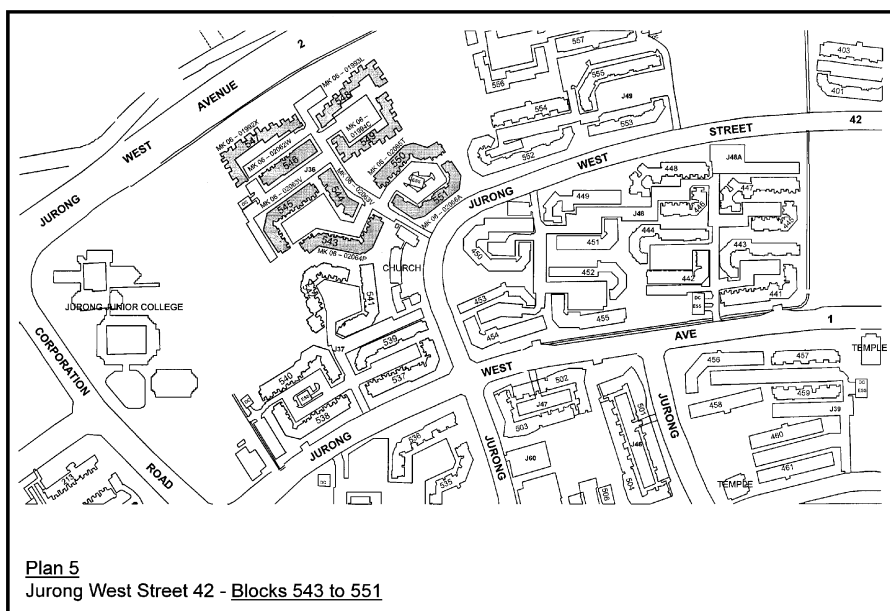
Plan 4
