FREE TRADE ZONES ACT 1966

FREE TRADE ZONES (DECLARED AREAS) (AMENDMENT) NOTIFICATION 2025

In exercise of the powers conferred by section 3(1) of the Free Trade Zones Act 1966, the Minister for Finance makes the following Notification:

Citation and commencement

1. This Notification is the Free Trade Zones (Declared Areas) (Amendment) Notification 2025 and comes into operation on 8 February 2025.

Amendment of First Schedule

2. In the Free Trade Zones (Declared Areas) Notification 1991, in the First Schedule, replace item (10) with —

“(10) *Tuas Port*

All that area occupied by “TUAS PORT — FREE TRADE ZONE” containing an area of approximately 3,545,435 square metres and bounded approximately as follows:

The boundary commences at a point 26,285.100 metres North and 3,963.400 metres East of the Singapore Land Authority SVY 21 Datum, and the boundary runs along successive lines of coordinates approximately as follows:

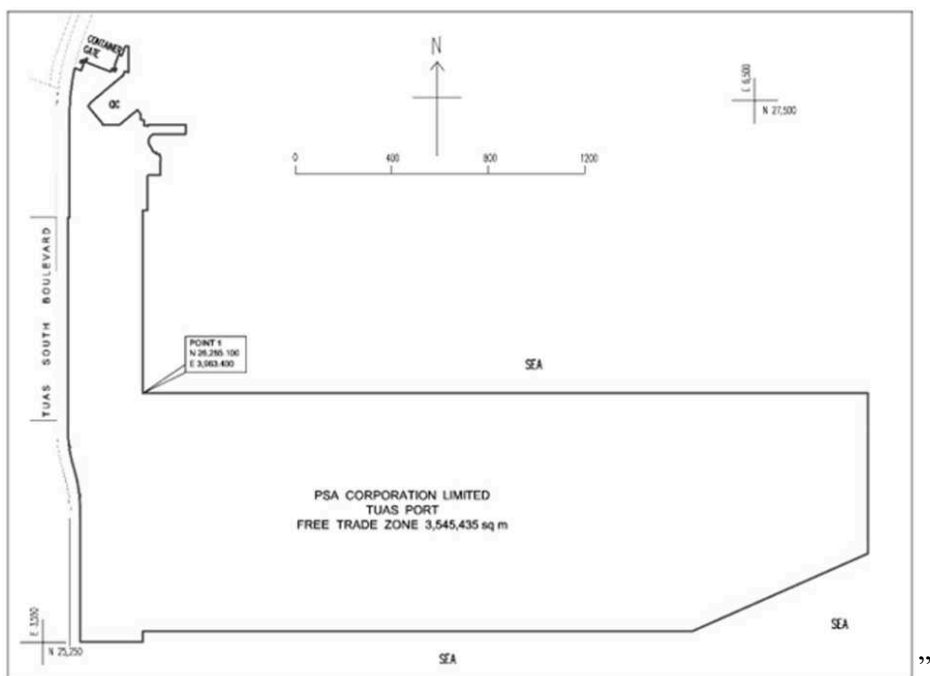
