# MAINTENANCE OF PARENTS (AMENDMENT NO. 3) RULES 2024

In exercise of the powers conferred by section 21 of the Maintenance of Parents Act 1995, the Minister for Social and Family Development makes the following Rules:

#### Citation and commencement

- 1.—(1) These Rules are the Maintenance of Parents (Amendment No. 3) Rules 2024 and, except for rules 2 and 3(k) to (o), (u) and (v), come into operation on 2 January 2025.
- (2) Rules 2 and 3(k) to (o), (u) and (v) come into operation on 16 January 2025.
