CHARITIES ACT (CHAPTER 37)

CHARITIES (EXEMPT CHARITIES) (AMENDMENT NO. 2) ORDER 2017

In exercise of the powers conferred by paragraph (b) of the Schedule to the Charities Act, the Minister for Culture, Community and Youth makes the following Order:

Citation and commencement

1.—(1) This Order is the Charities (Exempt Charities) (Amendment No. 2) Order 2017 and, except for paragraphs 2(b) and (g), 4(b) and (d), 5 and 6, comes into operation on 11 January 2017.

(2) Paragraphs 2(b) and 4(b) are deemed to have come into operation on 15 December 1998.

(3) Paragraphs 2(g) and 4(d) are deemed to have come into operation on 1 January 2001.

(4) Paragraphs 5 and 6 are deemed to have come into operation on 1 January 2005.

- (*h*) by deleting item (26) and substituting the following item:"(26) Paya Lebar Methodist Girls' School (Primary).";
- (i) by deleting item (28) and substituting the following item:"(28) Pei Hwa Presbyterian Primary School.";
- (*j*) by deleting item (34) and substituting the following item:"(34) St. Anthony's Canossian Primary School.";

- (k) by inserting, immediately after item (36), the following item:
 - "(36A) St. Joseph's Institution Junior."; and
- (l) by deleting item (38).
