## PLANNING <br> (DEVELOPMENT CHARGES) (AMENDMENT) RULES 2014

In exercise of the powers conferred by section 40 of the Planning Act, the Minister for National Development hereby makes the following Rules:

## Citation and commencement

1. These Rules may be cited as the Planning (Development Charges) (Amendment) Rules 2014 and shall come into operation on 1st March 2014.

## Amendment of First Schedule

2. The First Schedule to the Planning (Development Charges) Rules (R 5) is amended -
