SECURITIES AND FUTURES (TRADING VENUES FOR DERIVATIVES CONTRACTS IN THE EUROPEAN UNION) (AMENDMENT NO. 2) REGULATIONS 2020

In exercise of the powers conferred by sections 44(1) and 129N(1) of the Securities and Futures Act, the Monetary Authority of Singapore makes the following Regulations:

Citation and commencement

1. These Regulations are the Securities and Futures (Trading Venues for Derivatives Contracts in the European Union) (Amendment No. 2) Regulations 2020 and come into operation on 2 January 2021.

Deletion and substitution of Schedule
