ARRANGEMENT OF PARAGRAPHS

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 11) Notification 2012.

Exemption

2.—(1) The Minister hereby exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of —

- (a) the “Lucky Wheel (Revised)” promotion to be held from 1st April 2012 to 3rd May 2012 (both dates inclusive) (referred to in this paragraph as the relevant period); and
- (b) the lotteries to be held, as part of the “Lucky Wheel (Revised)” promotion, between 12 noon and 9.30 p.m. every day (except Fridays and Saturdays) during the relevant period,

at the Promotional Booth located within the Main Casino Floor at Basement 1 of the casino operated by Resorts World at Sentosa Pte. Ltd.

(2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a lottery, the time, date and place of the lottery, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
2. Every lottery shall be conducted by persons in the employment of Resorts World at Sentosa Pte. Ltd. only.
3. Every lottery shall be conducted in public.
4. Every lottery shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
5. Every lottery shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
6. Resorts World at Sentosa Pte. Ltd. shall, before the start of any of the lotteries, undertake to ensure that an audited statement of accounts is, together with the results of the lotteries, sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 4th August 2012.
