### **PUBLIC TRANSPORT COUNCIL ACT (CHAPTER 259B)**

#### **PUBLIC TRANSPORT COUNCIL (TICKET PAYMENT SERVICE LICENCE) (EXEMPTION) (AMENDMENT) ORDER 2020**

In exercise of the powers conferred by section 27 of the Public Transport Council Act, the Public Transport Council makes the following Order:

#### **Citation and commencement**

1. This Order is the Public Transport Council (Ticket Payment Service Licence) (Exemption) (Amendment) Order 2020 and comes into operation on 27 February 2020.

#### **Amendment of Schedule**
