TOWN COUNCIL OF MOULMEIN-KALLANG (CONSERVANCY AND SERVICE CHARGES) (AMENDMENT) BY-LAWS 2014

In exercise of the powers conferred by section 24(1) of the Town Councils Act, the Town Council for the Town of Moulmein-Kallang hereby makes the following By-laws:

Citation and commencement

1. These By-laws may be cited as the Town Council of Moulmein-Kallang (Conservancy and Service Charges) (Amendment) By-laws 2014 and shall come into operation on 1st April 2014.

Deletion of by-law 4

2. By-law 4 of the Town Council of Moulmein-Kallang (Conservancy and Service Charges) By-laws 2011 (G.N. No. S 742/2011) is deleted.

Deletion and substitution of Schedule

3. The Schedule to the Town Council of Moulmein-Kallang (Conservancy and Service Charges) By-laws 2011 is deleted and the following Schedule substituted therefor:

 - (b) where
 - (i) in the case of a flat sold by the Board any owner or essential occupier of the flat; or
 - (ii) in the case of a flat let out by the Board any tenant or authorised occupier of the flat,

has an interest in any residential property not owned by or vested in the Board, or in any industrial or commercial property, whether or not owned by or vested in the Board;

- (c) which is owned by or let to any body corporate; or
- (d) which is vacant.
- (2) The rates specified under the heading "*Reduced rate*" for items 1 to 7 of Part I and items 1 to 5 of Part II shall apply to all other flats.
- (3) In paragraph (1)
 - "authorised occupier" has the same meaning as in section 2(1) of the Housing and Development Act (Cap. 129);
 - "essential occupier", in relation to a flat sold by the Board, means any authorised occupier of the flat who, together with any lessee or other authorised occupier of the flat, will form the necessary

family or social nucleus to qualify the lessee to purchase or to continue to own the flat;

"tenant" means any tenant of the Board with respect to an entire flat.

- (4) The rates specified under the heading "*HUP rate*" for items 11, 12, 13 and 15 of Part I shall apply
 - (a) to any market or food centre which has been upgraded under the Hawker Centres Upgrading Programme; and
 - (b) to any commercial property which has been upgraded together with such market or food centre.
- (5) The rates specified under the heading "*Normal rate*" for items 10 to 15 of Part I shall apply to all other market or food centres and commercial properties.
