**ROAD TRAFFIC
(COLLECTION OF TOLL AT
WOODLANDS AND TUAS CHECKPOINTS)
(AMENDMENT) RULES 2020**

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Transport makes the following Rules:

Citation and commencement

1. These Rules are the Road Traffic (Collection of Toll at Woodlands and Tuas Checkpoints) (Amendment) Rules 2020 and come into operation on 2 March 2020.

Amendment of Schedule

2. The Schedule to the Road Traffic (Collection of Toll at Woodlands and Tuas Checkpoints) Rules (R 12) is amended —

- (a) by deleting “\$0.80” in item (1) of Part I and substituting “\$0.60”;
- (b) by deleting “\$1.00” in item (2) of Part I and substituting “\$0.80”;
- (c) by deleting “\$0.50” in item (4) of Part I and substituting “\$0.40”;
- (d) by deleting “\$3.00” in item (1) of Part III and substituting “\$2.50”;
- (e) by deleting “\$1.50” in item (1) of Part III and substituting “\$1.20”;
- (f) by deleting “\$2.50” in item (2) of Part III and substituting “\$2.10”;

- (g) by deleting “\$1.30” in item (2) of Part III and substituting “\$1.10”;
 - (h) by deleting “\$1.90” in item (5) of Part III and substituting “\$1.60”;
 - (i) by deleting “\$1.00” in item (5) of Part III and substituting “\$0.80”;
 - (j) by deleting “\$3.00” in item (1) of Part IV and substituting “\$2.50”;
 - (k) by deleting “\$1.50” in item (1) of Part IV and substituting “\$1.20”;
 - (l) by deleting “\$2.50” in item (2) of Part IV and substituting “\$2.10”;
 - (m) by deleting “\$1.30” in item (2) of Part IV and substituting “\$1.10”;
 - (n) by deleting “\$1.90” in item (5) of Part IV and substituting “\$1.60”; and
 - (o) by deleting “\$1.00” in item (5) of Part IV and substituting “\$0.80”.
