Citation and commencement

1. This Order may be cited as the Housing and Development (Precincts for Upgrading Works) (Home Improvement Programme) (No. 4) Order 2012 and shall come into operation on 11th April 2012.


Declaration of precincts for Home Improvement Programme

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out upgrading works in connection with the Home Improvement Programme.

1. All that part of the housing estate of the Board at Bedok North Road comprised in Lot numbers 01469K, 01468A, 01568V and 01567W in Mukim 28 and on which Apartment Blocks 107, 108, 109 and 110 are erected, and which is more particularly shaded in Plan 1.

BEDOK NORTH ROAD







ST GEORGE'S ROAD/LANE




Plan 3


PLAN 4

TAMPINES STREET 41




Plan 5
