**ROAD TRAFFIC ACT  
(CHAPTER 276)**

**RESTRICTION OF SPEED (ROADS) (AMENDMENT)  
NOTIFICATION 2005**

In exercise of the powers conferred by section 63(2) of the Road Traffic Act, the Minister for Home Affairs hereby makes the following Notification:

**Citation and commencement**

1. This Notification may be cited as the Restriction of Speed (Roads) (Amendment) Notification 2005 and shall come into operation on 1st April 2005.

**Deletion and substitution of Second Schedule**

2. The Second Schedule to the Restriction of Speed (Roads) Notification (N 6) is deleted and the following Schedule substituted therefor:

**“SECOND SCHEDULE**

Paragraph 2

*60 Kilometres Per Hour*

Alexandra Road — that part of Alexandra Road between Queensway and Lower Delta Road.

Ang Mo Kio Avenue 5 — that part of Ang Mo Kio Avenue 5 between Yio Chu Kang Road and the Central Expressway.

Ang Mo Kio Avenue 6.

Bedok North Avenue 1 — that part of Bedok North Avenue 1 between Bedok North Road and New Upper Changi Road.

Bedok North Road — that part of Bedok North Road between Tampines Avenue 10 and Bedok North Avenue 1.

Bedok South Avenue 1.

Bedok South Road — that part of Bedok South Road between New Upper Changi Road and Bedok South Avenue 1.

Bendemeer Road.

Canberra Link — that part of Canberra Link between Sembawang Road and Canberra Road.

Holland Road — that part of Holland Road between Napier Road and Farrer Road.

Jalan Boon Lay — that part of Jalan Boon Lay between Boon Lay Way and Jurong West Avenue 4.

Lim Chu Kang Road — that part of Lim Chu Kang Road between Old Lim Chu Kang Road (North end) and the end of Lim Chu Kang Road.

Marine Parade Road — that part of Marine Parade Road between Bedok South Avenue 1 and Telok Kurau Road.

Moulmein Road.

Pasir Ris Drive 12.

Punggol East — that part of Punggol East between Punggol Field and Punggol Dale.

Queensway — that part of Queensway between Holland Road and Commonwealth Avenue.

Republic Avenue.

Sembawang Road — that part of Sembawang Road —

(a) between Mandai Road and Transit Road; and

(b) between Jalan Mata Ayer and Admiralty Road East.

Sembawang Way.

Serangoon Road — that part of Serangoon Road between Lavender Street and Woodsville Flyover.

Thomson Road.

Ulu Pandan Road.

Upper Bukit Timah Road — that part of Upper Bukit Timah Road between Clementi Road and Old Jurong Road.

Upper Changi Road East.

Upper Serangoon Road — that part of Upper Serangoon Road —

(a) between Woodsville Flyover and Potong Pasir Avenue 1; and

(b) between Bartley Road and Hougang Avenue 7.

Upper Thomson Road — that part of Upper Thomson Road —

(a) between Yio Chu Kang Road and Thomson Road; and

(b) between its 14th kilometre post and Mandai Road.

West Coast Ferry Road — that part of West Coast Ferry Road between Harbour Drive and West Coast Highway.

Woodlands Avenue 7.

Woodlands Avenue 8.

Yio Chu Kang Road — that part of Yio Chu Kang Road between Serangoon North Avenue 1 and the Central Expressway Flyover.

Yishun Avenue 1 — that part of Yishun Avenue 1 between Lentor Avenue and Yishun Avenue 6.

Yishun Avenue 2 — that part of Yishun Avenue 2 between Lentor Avenue and Yishun Avenue 7.

Yishun Avenue 7.”.

**Amendment of Third Schedule**

**3.** The Third Schedule to the Restriction of Speed (Roads) Notification is amended —

(a) by inserting, immediately below the item relating to “Bukit Timah Road”, the following item:

“Canberra Link — that part of Canberra Link between Yishun Avenue 2 and Sembawang Road.”;

(b) by inserting, immediately below the item relating to “Farrer Road”, the following items:

“Gambas Avenue.

Jalan Boon Lay — that part of Jalan Boon Lay between Jurong Hill Flyover and Boon Lay Way.”;

(c) by inserting, immediately below the item relating to “Lentor Avenue”, the following item:

“Lim Chu Kang Road — that part of Lim Chu Kang Road between Jalan Bahar and Old Lim Chu Kang Road (North end).”;

(d) by inserting, immediately below the item relating to “Pioneer Road”, the following item:

“Punggol East — that part of Punggol East between Tampines Expressway and Punggol Field.”;

(e) by inserting, immediately below the item relating to “Seletar Avenue 1”, the following item:

“Sembawang Avenue.”;

(f) by inserting, immediately below the item relating to “Sembawang Road”, the following item:

“Sengkang East Drive.”;

(g) by inserting, immediately below the item relating to “Upper Jurong Road”, the following items:

“Upper Serangoon Road — that part of Upper Serangoon Road —

(a) between Potong Pasir Avenue 1 and Bartley Road; and

(b) between Hougang Avenue 7 and Buangkok Drive.

Upper Serangoon Viaduct.”;

(h) by inserting, immediately below the item relating to “Whitley Road”, the following item:

“Woodlands Avenue 10.”; and

(i) by inserting, immediately below the item relating to “Yishun Avenue 1”, the following item:

“Yishun Avenue 2 — that part of Yishun Avenue 2 between Yishun Avenue 7 and Canberra Link.”.
