1. This Order may be cited as the Housing and Development (Precincts for Lift Upgrading Works) (No. 5) Order 2011 and shall come into operation on 1st April 2011.

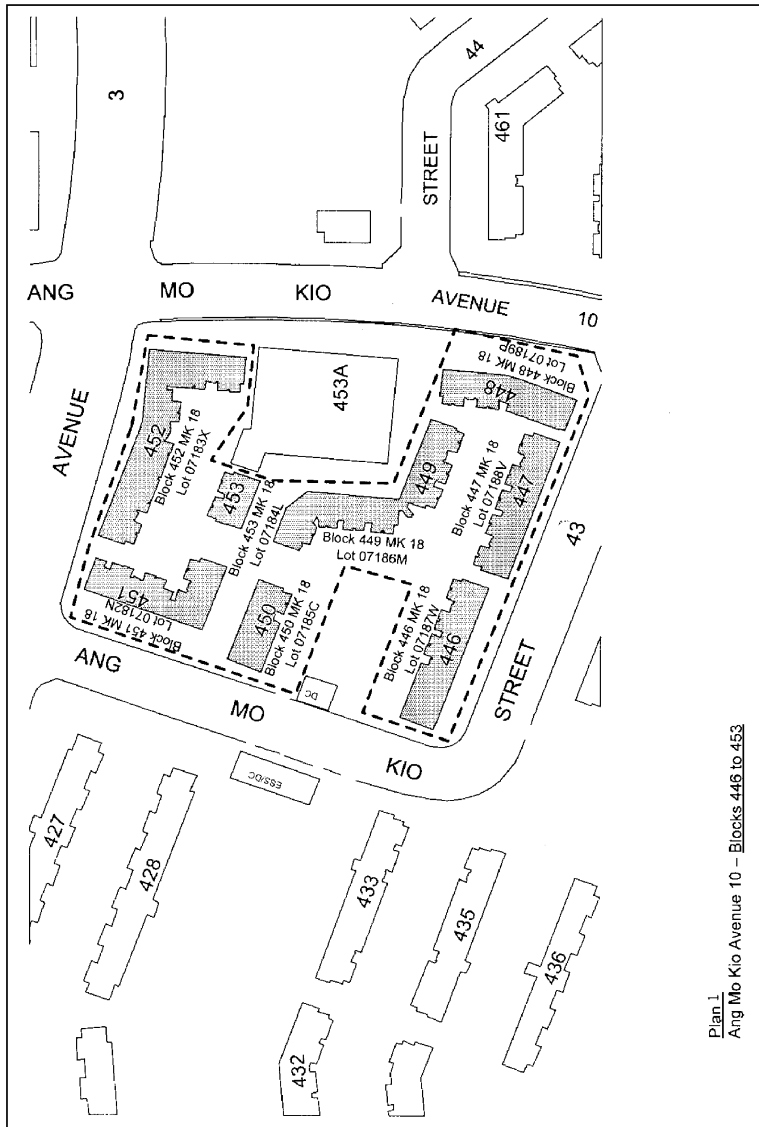
Declaration of precincts for lift upgrading works

2. The parts of the housing estates of the Board described in the Schedule are hereby declared to be precincts for the purpose of carrying out lift upgrading works.

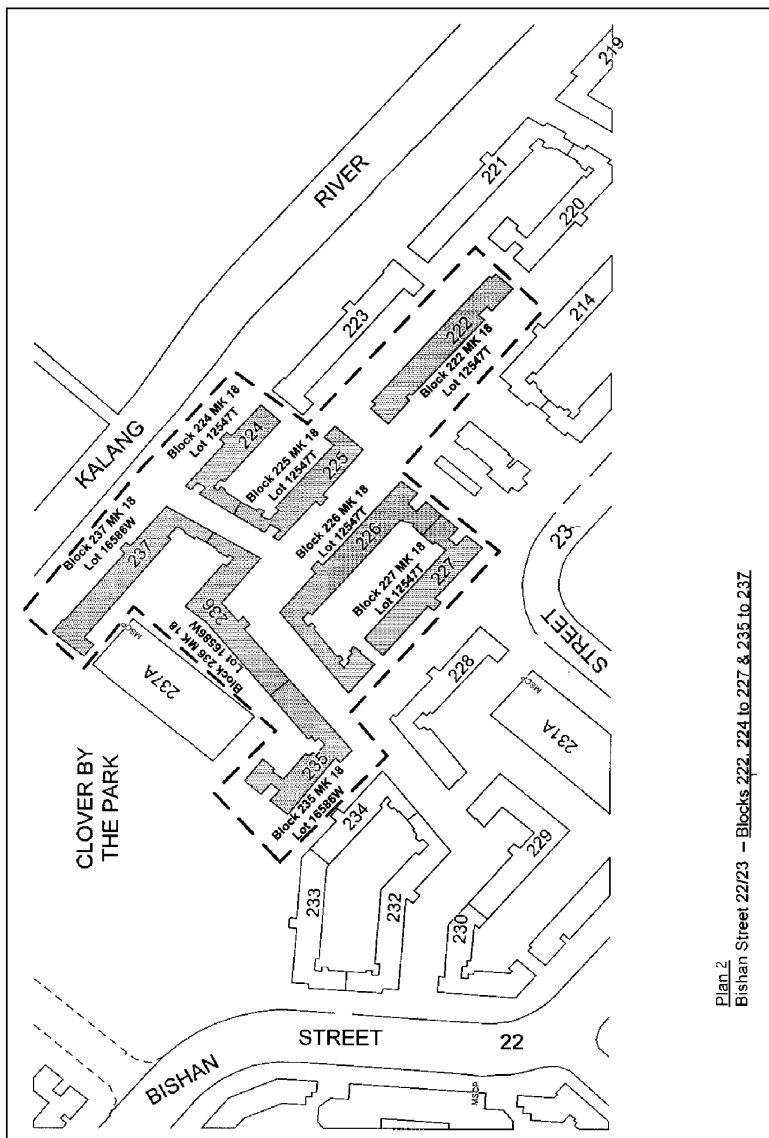
PLAN 1

BISHAN STREET 22/23

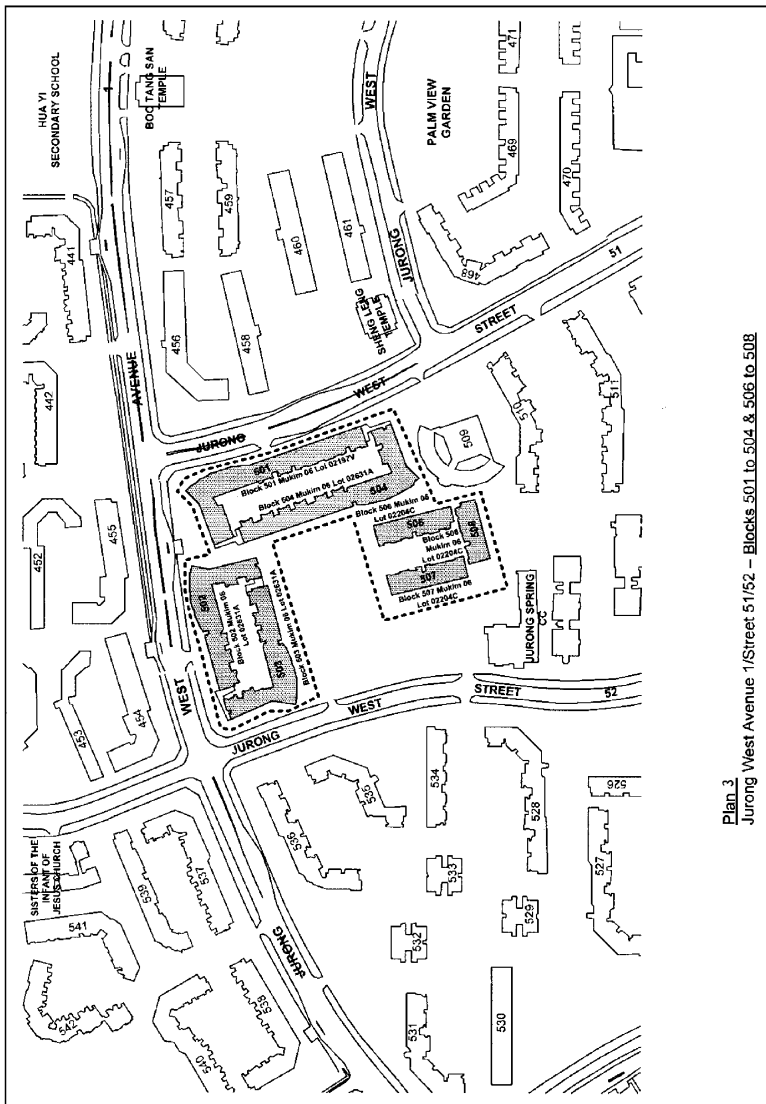


Plan 2

JURONG WEST AVENUE 1/STREET 51/52



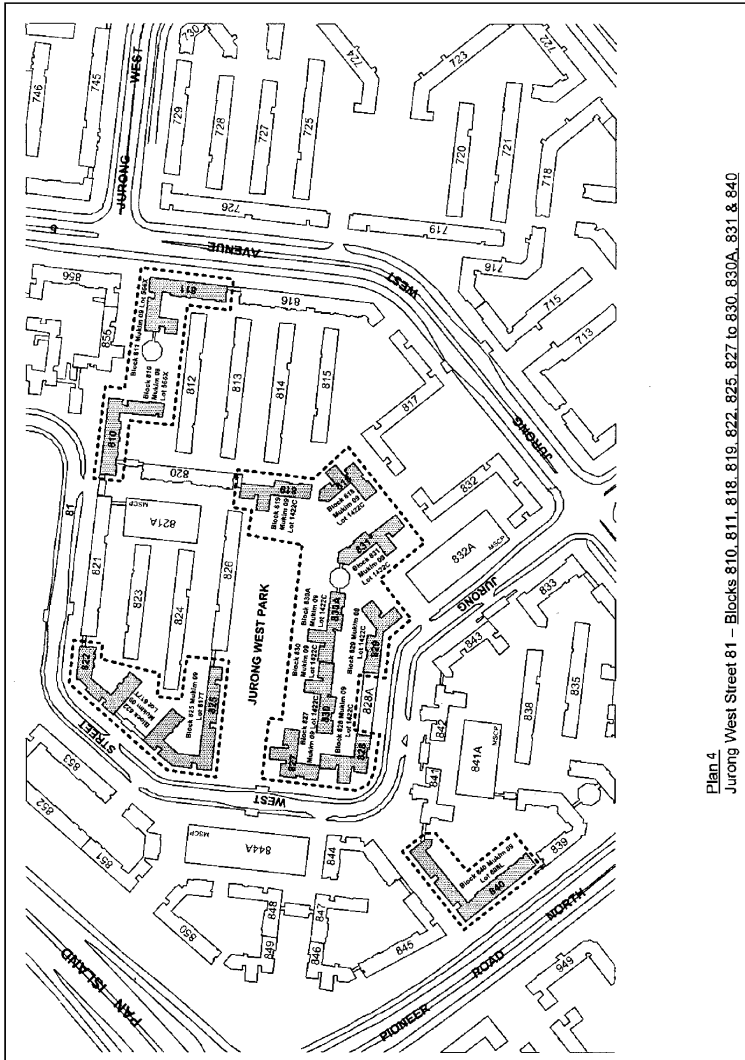

JURONG WEST STREET 81

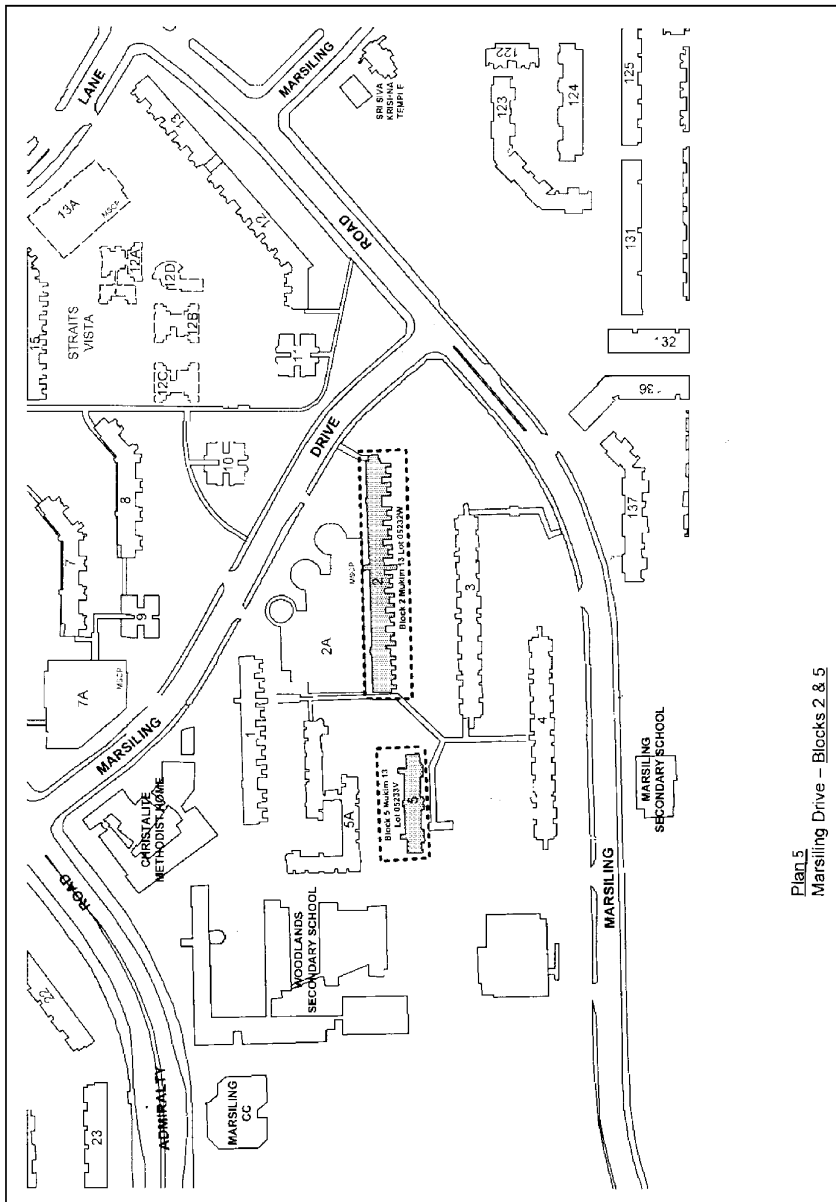

MARSILING DRIVE

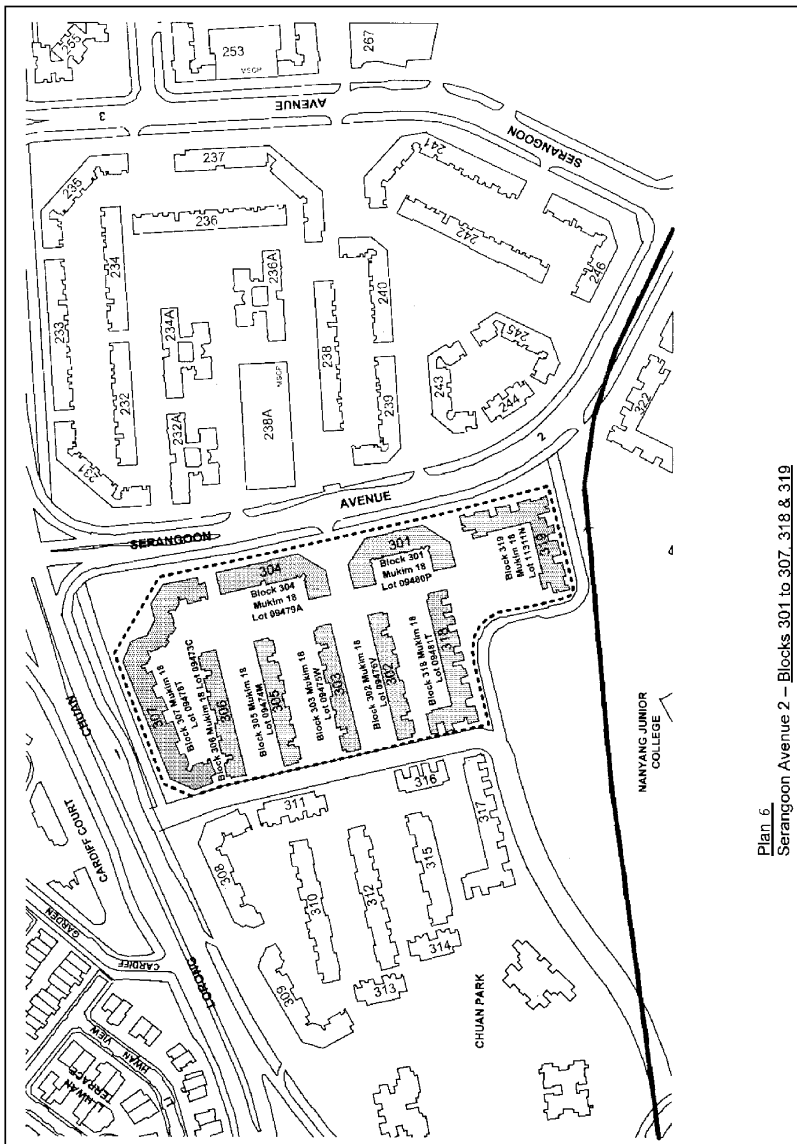


Plan 5

SERANGOON AVENUE 2



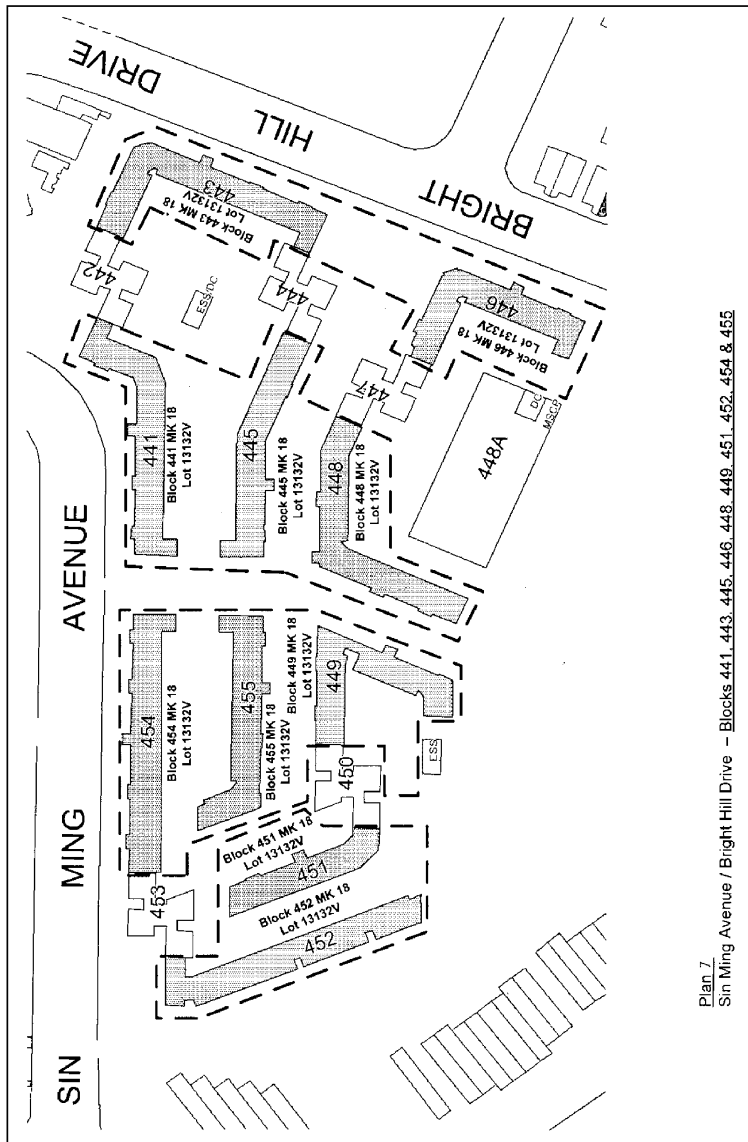

SIN MING AVENUE/BRIGHT HILL DRIVE



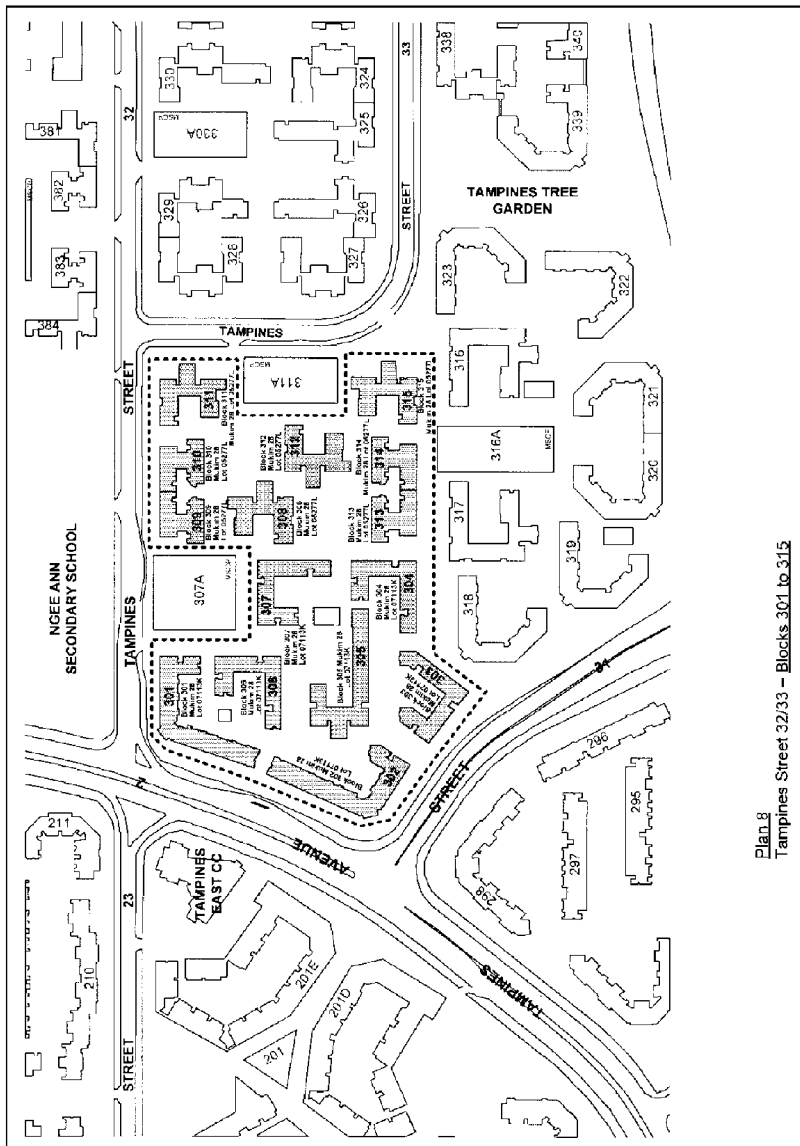
Plan 7

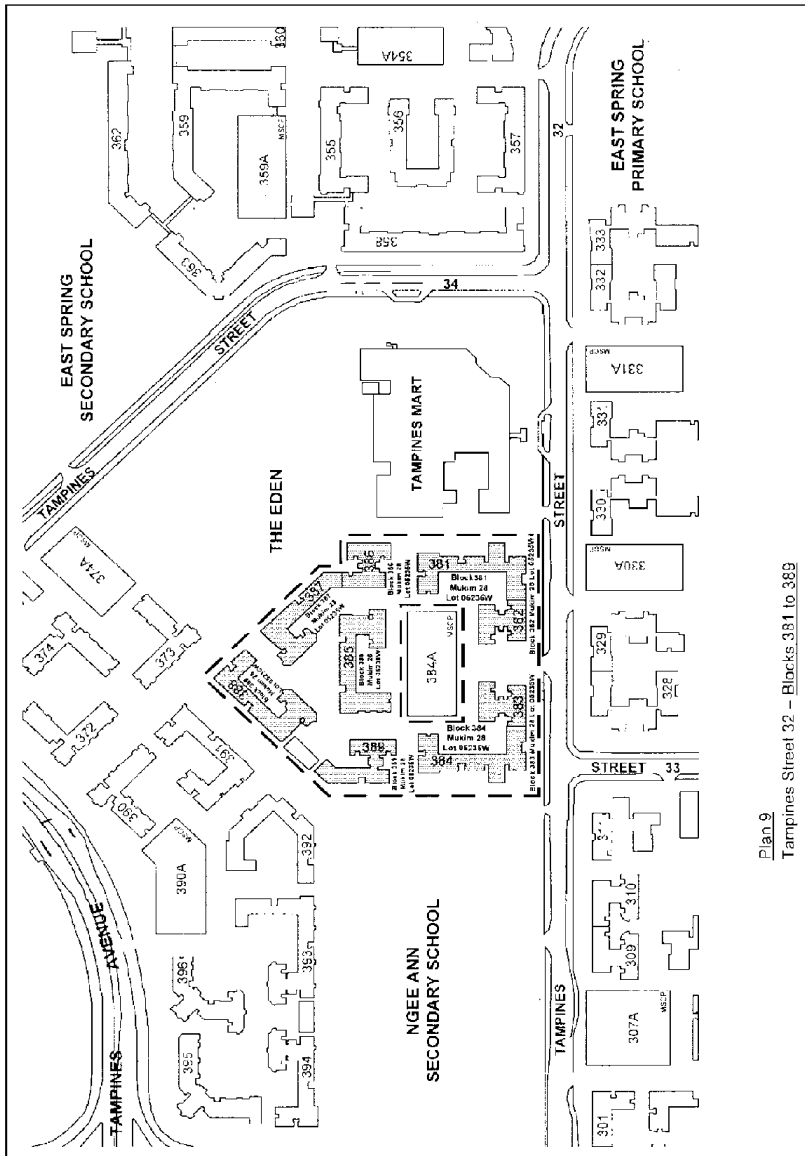

TAMPINES STREET 32

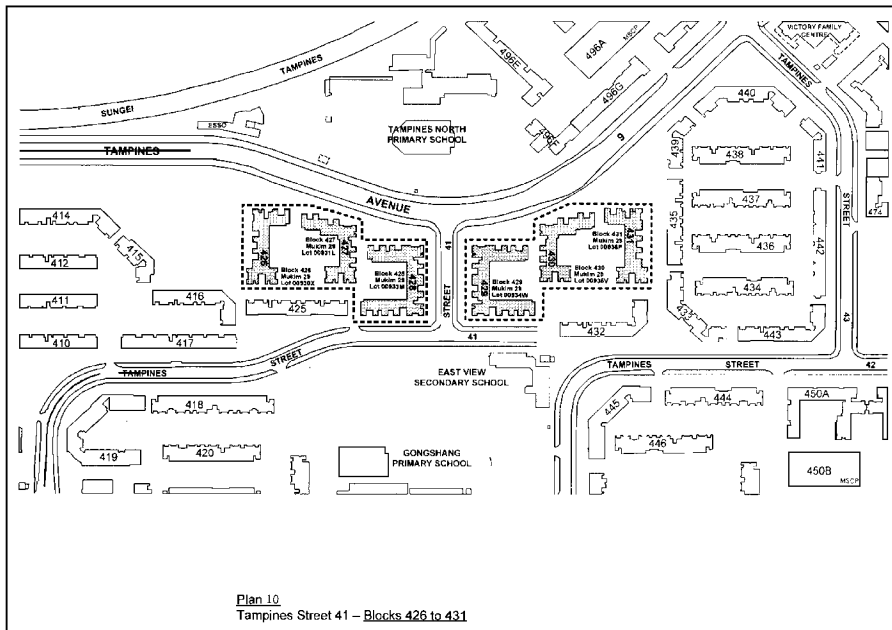
