POLITICAL DONATIONS ACT (CHAPTER 236)

POLITICAL DONATIONS (AMENDMENT) REGULATIONS 2012

In exercise of the powers conferred by section 32 of the Political Donations Act, the Prime Minister hereby makes the following Regulations:

Citation and commencement

1. These Regulations may be cited as the Political Donations (Amendment) Regulations 2012 and shall come into operation on 27th April 2012.

Amendment of Schedule

2. Forms 3, 4 and 5 of the Schedule to the Political Donations Regulations (Rg 2) are deleted and the following Forms substituted therefor:
