PUBLIC TRANSPORT COUNCIL ACT (CHAPTER 259B)

PUBLIC TRANSPORT COUNCIL (TICKET PAYMENT SERVICE LICENCE) (EXEMPTION) (AMENDMENT) ORDER 2021

In exercise of the powers conferred by section 27 of the Public Transport Council Act, the Public Transport Council makes the following Order:

Citation and commencement

1. This Order is the Public Transport Council (Ticket Payment Service Licence) (Exemption) (Amendment) Order 2021 and comes into operation on 24 March 2021.
