### **ROAD TRAFFIC ACT 1961**

#### **ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 2) RULES 2023**

In exercise of the powers conferred by section 34D of the Road Traffic Act 1961, the Minister for Transport makes the following Rules:

#### **Citation and commencement**

1. These Rules are the Road Traffic (Electronic Road Pricing System) (Amendment No. 2) Rules 2023 and come into operation on 3 April 2023.

#### **Amendment of First Schedule**

2. In the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015), in the First Schedule —
