INTERPRETATION ACT 1965

INTERPRETATION (DELEGATIONS BY MINISTER FOR HEALTH) (AMENDMENT) ORDER 2025

In exercise of the powers conferred by section 36 of the Interpretation Act 1965, the Minister for Health makes the following Order:

Citation and commencement

1. This Order is the Interpretation (Delegations by Minister for Health) (Amendment) Order 2025 and comes into operation on 20 March 2025.

Replacement of paragraph 2 and new paragraph 2A

2. In the Interpretation (Delegations by Minister for Health) Order 2024 (G.N. No. S 134/2024) (called in this Order the principal Order), replace paragraph 2 with —

"Definitions

- 2. In this Order
 - "MOH Permanent Secretary" means any Permanent Secretary to the Ministry of Health;
 - "MOH political office holder" means
 - (a) any Second Minister for Health;
 - (b) any Minister of State assigned by the Prime Minister to assist the Minister for Health; and
 - (c) any Parliamentary Secretary assigned by the Prime Minister to assist the Minister for Health.

Delegations to political office holders

2A. The Minister for Health, with the Prime Minister's approval, delegates the functions under the provisions of the Acts specified in the first column of the First Schedule to the persons specified in the third column of the First Schedule, subject to the conditions (if any) specified in the fourth column of the First Schedule.".

Amendment of paragraph 3

3. In the principal Order, in paragraph 3, replace "Schedule" wherever it appears with "Second Schedule".

New First Schedule

4. In the principal Order, after paragraph 3, insert —
