CONSTITUTION OF THE REPUBLIC OF SINGAPORE

PUBLIC SERVICE (SPECIAL AND SENIOR PERSONNEL BOARDS) (AMENDMENT NO. 2) ORDER 2016

In exercise of the powers conferred by Article 110D(1) and (2) of the Constitution of the Republic of Singapore, the President, on the advice of the Deputy Prime Minister and Coordinating Minister for National Security, Prime Minister's Office, Mr Teo Chee Hean, who is charged with the responsibility for the portfolio of the Prime Minister as regards human resource management in the Civil Service, makes the following Order:

Citation and commencement

1. This Order is the Public Service (Special and Senior Personnel Boards) (Amendment No. 2) Order 2016 and comes into operation on 1 May 2016.

Amendment of Schedule

2. The Schedule to the Public Service (Special and Senior Personnel Boards) Order 2010 (G.N. No. S 824/2010) is amended —

- (a) by deleting the name “Mr Benny Lim Siang Hoe” in the third column of item 1 and substituting the name “Ms Chan Lai Fung”;
- (b) by deleting the name “Mrs Ow Foong Pheng” in the third column of item 2 and substituting the name “Mrs Tan Ching Yee”;
- (c) by inserting, immediately after the name “Mr Albert Chua” in the third column of item 2, the name “Mr Loh Khum Yean”;
- (d) by deleting the name “Mr Benny Lim Siang Hoe” in the third column of item 3;

- (e) by deleting the name “Mrs Tan Ching Yee” in the third column of item 4 and substituting the name “Mr Leo Yip”;
 - (f) by deleting the name “Mr Loh Khum Yean” in the third column of item 4 and substituting the name “Mrs Ow Foong Pheng”;
 - (g) by deleting the name “Mr Benny Lim Siang Hoe” in the third column of item 4 and substituting the name “Mr Gabriel Lim”;
 - (h) by deleting the name “Mr Benny Lim Siang Hoe” in the third column of item 5 and substituting the name “Mrs Tan Ching Yee”; and
 - (i) by deleting the name “Mrs Tan Ching Yee” in the third column of item 6 and substituting the name “Ms Yong Ying-I”.
