# ROAD TRAFFIC ACT (CHAPTER 276)

## ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 2) RULES 2016

In exercise of the powers conferred by sections 34D and 140(1) of the Road Traffic Act, the Minister for Transport makes the following Rules:

### Citation and commencement

1. These Rules are the Road Traffic (Electronic Road Pricing System) (Amendment No. 2) Rules 2016 and come into operation on 2 May 2016.

#### Amendment of First Schedule

- **2.** The First Schedule to the Road Traffic (Electronic Road Pricing System) Rules 2015 (G.N. No. S 226/2015) is amended
  - (a) by deleting Tables IV and V of Division 2 of Part 2 and substituting the following Table:
