#### COMMON GAMING HOUSES (EXEMPTION) (NO. 17) NOTIFICATION 2015

In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs makes the following Notification:

#### **Citation**

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 17) Notification 2015.

#### **Exemption**

2.—(1) The Minister exempts Resorts World at Sentosa Pte. Ltd. from the provisions of the Act in respect of —

- (a) the “RWS Premium Surprise 2015” promotion to be held from 10 April 2015 to 9 May 2015 (both dates inclusive); and
- (b) the draw to be held at the Festive Hotel membership office (Level B1) of Resorts World at Sentosa Pte. Ltd., as part of that promotion, on 10 April 2015 between 2 p.m. and 5 p.m., the results of which are to be announced from 30 April 2015 to 9 May 2015 (both dates inclusive).

(2) The exemption is subject to compliance by Resorts World at Sentosa Pte. Ltd. with the conditions specified in the Schedule.

## THE SCHEDULE

Paragraph 2

### CONDITIONS

1. The following information must be disclosed in printed publicity material, made available to every participant of the draw:
  - (a) the name and address of the organiser;
  - (b) how a person may participate in the draw;
  - (c) the manner in which the draw is promoted and conducted;
  - (d) the price of participating in the draw;
  - (e) the details of the prizes for the draw;
  - (f) the manner of distribution of the prizes for the draw;
  - (g) the time, date and place of the draw.
2. The draw may only be conducted by persons in the employment of Resorts World at Sentosa Pte. Ltd.
3. The draw must be witnessed and audited by a public accountant who is not in the employment of Resorts World at Sentosa Pte. Ltd.
4. The draw must not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act to be —
  - (a) a lottery for the purposes of the Act; or
  - (b) a game of chance or a mixed game of chance and skill for the purposes of the Act.
5. The draw must not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act to be an instrument or appliance for gaming.
6. The results of the draw must be announced at the designated redemption counters or the membership kiosks within the premises of the casino of Resorts World at Sentosa Pte. Ltd.
7. Resorts World at Sentosa Pte. Ltd. must, before the start of the draw, undertake to ensure that an audited statement of accounts and the results of the draw are sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 10 August 2015.
