In exercise of the powers conferred by section 142 of the Road Traffic Act 1961, the Minister for Transport makes the following Order:

# Citation and period in force

- 1.—(1) This Order is the Road Traffic (Tiong Woon Corporation Project and Contracting Pte. Ltd. Exemption) Order 2023.
- (2) This Order is in force for the period between 20 April 2023 and 30 June 2023 (both dates inclusive).

# **Definitions**

- 2. In this Order
  - "specified purpose" means the transportation of any load for any construction project undertaken by Tiong Woon Corporation Project and Contracting Pte. Ltd. (UEN 200516490E), a company incorporated under the Companies Act 1967;
  - "specified road" means any of the roads delineated by the black-coloured line in the map set out in the First Schedule;

- "specified rules" means the rules set out in the Second Schedule;
- "specified vehicle" means a motor vehicle known as a self-propelled modular trailer that
  - (a) is remotely operated through a remote control;
  - (b) is used for the purpose of transporting any load; and
  - (c) is capable of being driven on its own without being attached to any other vehicle.


# **Exemption**

**3.** Sections 5(1) and (5), 10, 10A, 11, 12, 15, 29, 34E and 91 of the Act, and the specified rules, do not apply to (or in relation to) a specified vehicle that is used on a specified road for the specified purpose.
