In exercise of the powers conferred by section 55(2) of the Bus Services Industry Act 2015, the Minister for Transport makes the following Regulations:

## Citation and commencement

**1.** These Regulations are the Bus Services Industry (Savings and Transitional) Regulations 2016 and come into operation on 22 January 2016.

#### **Public bus services contracts**

- **2.**—(1) Each contract specified in the Schedule (called in this regulation a specified contract) is deemed to be a public bus services contract for the purposes of the Act.
- (2) To avoid doubt, the Act does not prejudice any right under a specified contract that accrued before the date of commencement of the Act.
