# BOUNDARIES AND SURVEY MAPS (MISCELLANEOUS AMENDMENTS) RULES 2023

In exercise of the powers conferred by section 21(2) of the Boundaries and Survey Maps Act 1998, the Singapore Land Authority, with the approval of the Minister for Law, makes the following Rules:
