Citation

1. This Notification is the Civil Aviation Authority of Singapore (Designated Operating Entities) Notification 2025.

Designated operating entities

2.—(1) The Authority designates each entity specified in the first column of Part 1 or 2 of the Schedule as a designated operating entity.

(2) The designation of an entity as a designated operating entity takes effect on the date specified for that entity in the second column of Part 1 or 2 of the Schedule, as the case may be.
