SINGAPORE ACADEMY OF LAW ACT (CHAPTER 294A)

SINGAPORE ACADEMY OF LAW (AMENDMENT) RULES 2011

In exercise of the powers conferred by section 27 of the Singapore Academy of Law Act, the Senate of the Singapore Academy of Law hereby makes the following Rules:

Citation and commencement

1. These Rules may be cited as the Singapore Academy of Law (Amendment) Rules 2011 and shall come into operation on 3rd May 2011.

Amendment of Fourth Schedule

2. The Fourth Schedule to the Singapore Academy of Law Rules (R 1) is amended —

- (*a*) by inserting, immediately after the words "Ordinary members" in item 2 of Part I and item 2 of Part II, the words "who are advocates and solicitors or Legal Service Officers,";
- (*b*) by deleting the word "ONWARDS" in the heading to Part II and substituting the words "TO 2010";
- (c) by deleting the word "onwards" in the column heading of the seventh column of the table in Part II and substituting the words "to 2010"; and

(d) by inserting, immediately after Part II, the following Part:

"PART III

ANNUAL SUBSCRIPTIONS FROM 2011 ONWARDS

The annual subscription payable by a member belonging to a category of members specified in the first column for the subscription year 2011 and for every subsequent subscription year shall be as specified in the second column.
