Citation and commencement

1. This Order is the Infrastructure Protection (Protected Places) (No. 6) Order 2021 and comes into operation on 8 April 2021.

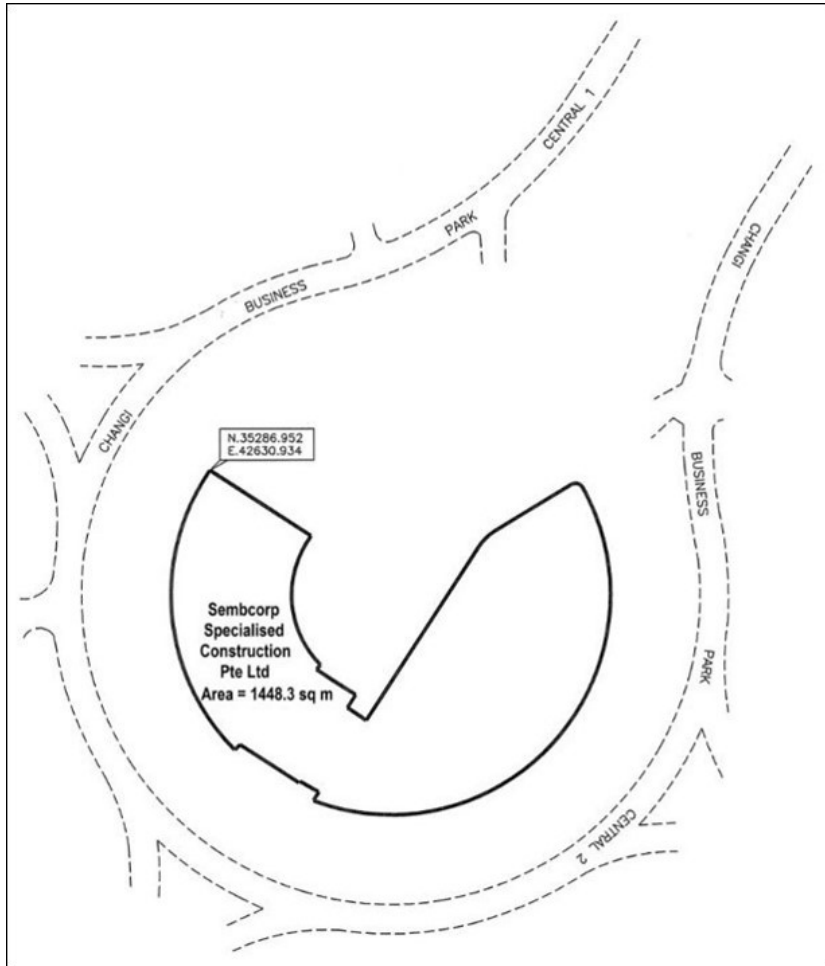
