In exercise of the powers conferred by section 24 of the Common Gaming Houses Act, the Minister for Home Affairs hereby makes the following Notification:

Citation

1. This Notification may be cited as the Common Gaming Houses (Exemption) (No. 19) Notification 2012.

Exemption

2.—(1) The Minister hereby exempts Marina Bay Sands Pte. Ltd. from the provisions of the Act in respect of the “Riches in Ruby Lucky Draw” promotion to be held from 1st June 2012 to 30th December 2012 (both dates inclusive) and the draws to be held on every Friday, Saturday and Sunday during that period between 6 p.m. and 10.15 p.m. at the Ruby Room of Marina Bay Sands.

(2) The exemption is subject to compliance by Marina Bay Sands Pte. Ltd. with the conditions specified in the Schedule.

THE SCHEDULE

Paragraph 2

CONDITIONS

1. The methodology of the promotion, the details of the prizes to be distributed, their manner of distribution and, if the winners are determined solely or partly by a draw, the time, date and place of the draw, shall be disclosed in printed publicity material, copies of which shall be freely available to all participants.
2. Every lucky draw shall be conducted by persons in the employment of Marina Bay Sands Pte. Ltd. only.
3. Every lucky draw shall be conducted in public.
4. Every lucky draw by means of a computerised system which is not conducted in public shall be witnessed and audited by a public accountant who is not in the employment of Marina Bay Sands Pte. Ltd.
5. Every lucky draw shall not involve the use of any game, method, device, scheme or competition declared by the Minister in a notification under section 2(3) of the Act.
6. Every lucky draw shall not involve the use of any instrument or appliance for gaming declared by the Minister in a notification under section 2(4) of the Act.
7. Marina Bay Sands Pte. Ltd. shall, before the start of any of the lucky draws, undertake to ensure that an audited statement of accounts shall, together with the results of the lucky draws, be sent by registered post to the Head, Specialised Crime Policy Branch, Criminal Investigation Department, no later than 31st March 2013.
