**FREE TRADE ZONES ACT
(CHAPTER 114)**

**FREE TRADE ZONES
(DECLARED AREAS) (AMENDMENT)
NOTIFICATION 2012**

In exercise of the powers conferred by section 3(1) of the Free Trade Zones Act, the Minister for Finance hereby makes the following Notification:

Citation and commencement

1. This Notification may be cited as the Free Trade Zones (Declared Areas) (Amendment) Notification 2012 and shall come into operation on 4th June 2012.

Amendment of First Schedule

2. The First Schedule to the Free Trade Zones (Declared Areas) Notification (N 3) is amended by deleting item (10) and substituting the following item:

“(10) *Airport Logistics Park of Singapore*

All that area comprised of Lots 4359P, 4350A, 4361V, 4200K, 4360W, 4348K, 4110A, 4111K, 4112N, 4269V, 4285W, 4274T and part of Lot 4693A Mukim No. 31 (Changi) occupied by “AIRPORT LOGISTICS PARK OF SINGAPORE — FREE TRADE ZONE” containing an area of approximately 248,279 square metres and bounded approximately as follows:

The boundary commences at the south-eastern corner of the aforesaid “AIRPORT LOGISTICS PARK OF SINGAPORE — FREE TRADE ZONE” which point of commencement is 39,558.087 metres North and 47,027.301 metres East of the Singapore Land Authority SVY 21 Datum, and the boundary runs along successive lines of co-ordinates approximately as follows:

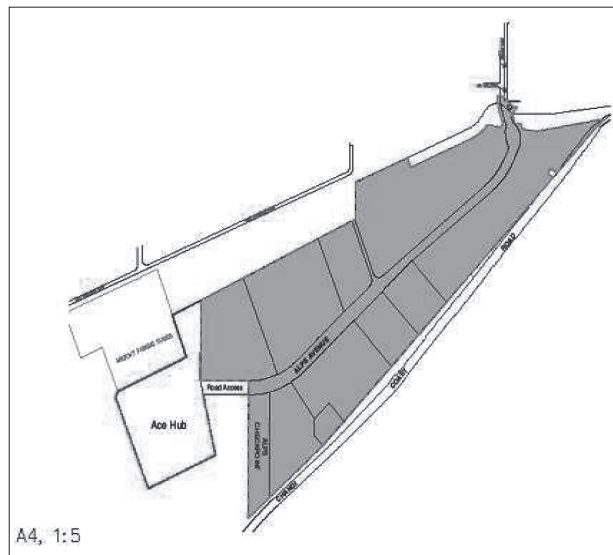
