## ROAD TRAFFIC ACT (CHAPTER 276)

## ROAD TRAFFIC (ELECTRONIC ROAD PRICING SYSTEM) (AMENDMENT NO. 2) RULES 2021

In exercise of the powers conferred by section 34D of the Road Traffic Act, the Minister for Transport makes the following Rules:

#### Citation and commencement

1. These Rules are the Road Traffic (Electronic Road Pricing System) (Amendment No. 2) Rules 2021 and come into operation on 12 April 2021.

#### **Amendment of First Schedule**
