# CENTRAL PROVIDENT FUND ACT (CHAPTER 36)

## CENTRAL PROVIDENT FUND (MINIMUM SUM PLUS SCHEME) (AMENDMENT) REGULATIONS 2012

In exercise of the powers conferred by section 77(1)(p) of the Central Provident Fund Act, the Minister for Manpower, after consulting with the Central Provident Fund Board, hereby makes the following Regulations:

#### Citation and commencement

1. These Regulations may be cited as the Central Provident Fund (Minimum Sum Plus Scheme) (Amendment) Regulations 2012 and shall come into operation on 1st June 2012.

## Amendment of regulation 3

- **2.** Regulation 3 of the Central Provident Fund (Minimum Sum Plus Scheme) Regulations (Rg 27) is amended
  - (a) by deleting the words "setting aside the minimum sum" in the definition of "additional sum" and substituting the words "his minimum sum has been set aside"; and
  - (b) by deleting the definition of "subsistence amount" and substituting the following definition:
    - ""subsistence amount" means, in relation to a member who is entitled to withdraw or be paid a monthly income under regulation 12 of the Central Provident Fund (Minimum Sum Scheme) Regulations (Rg 16), regulation 8A of the Central Provident Fund (Revised Minimum Sum Scheme) Regulations (Rg 2), regulation 8A of the Central Provident Fund (New Minimum Sum Scheme) Regulations (Rg 31) or regulation 10C of the Provident Fund Central (Minimum Topping-Up Scheme) Regulations (Rg 3) on a date

specified in the first column of the Schedule, the amount set out in the second column of the Schedule against the specified date.".

#### **Amendment of Schedule**

- **3.** The Schedule to the Central Provident Fund (Minimum Sum Plus Scheme) Regulations is amended
  - (a) by deleting the words "the monthly withdrawal or payment under regulation 12 of the Central Provident Fund (Minimum Sum Scheme) Regulations (Rg 16) or regulation 9 of the Central Provident Fund (Revised Minimum Sum Scheme) Regulations (Rg 2)" in the column heading of the first column and substituting the words "withdrawal or payment of monthly income"; and
  - (b) by deleting the words "but before 1st July 2004" in the first column of item (d).
