In exercise of the powers conferred by sections 8(1) and 13(1) of the Infrastructure Protection Act 2017, the Minister for Home Affairs makes the following Order:

##### **Citation and commencement**

1. This Order is the Infrastructure Protection (Protected Areas) Order 2025 and comes into operation on 18 January 2025.

##### **Premises declared to be protected area**

2. The premises described in the second column of the Schedule are declared to be a protected area for the purposes of the Act, and the person specified in the first column of that Schedule is designated as the authority of the protected area.

##### **Revocation**

3. Revoke the Protected Areas Order 2012 (G.N. No. S 350/2012).

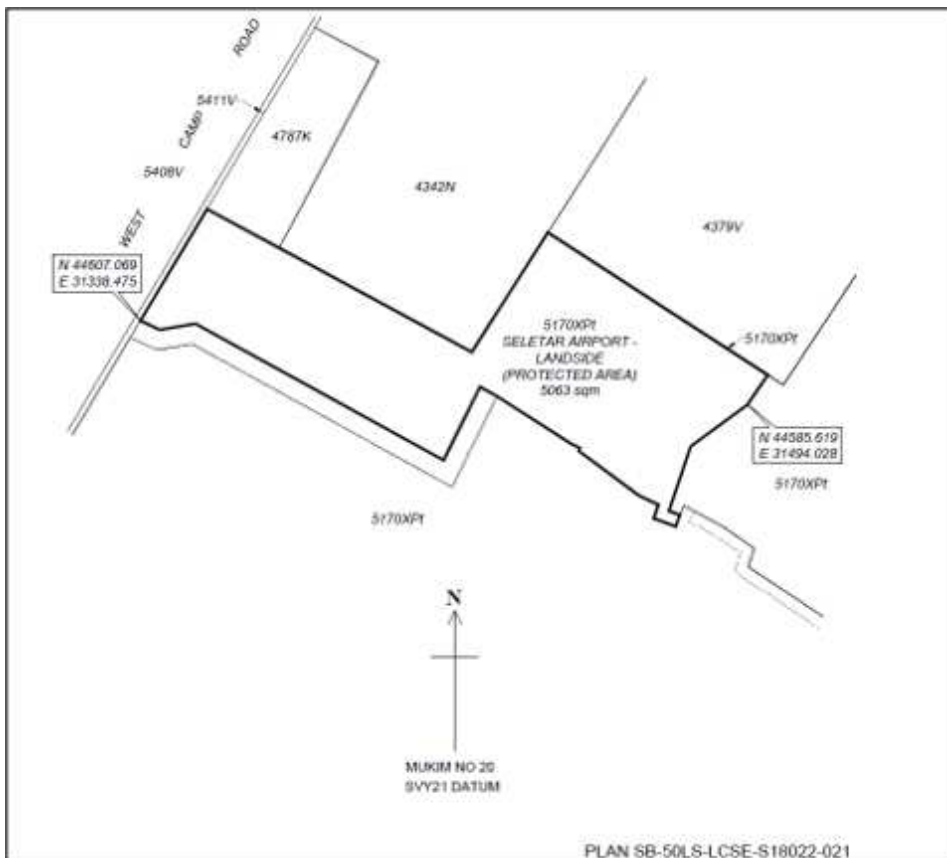
